The method of payment will be direct deposit under Federal Government of Pakistan Head of Account **C-03870**. Non tax receipts – others on Challan 32-A either in the State Bank of Pakistan or National Bank of Pakistan, interested bidders who wish to receive the bid documents through courier should provide an additional amount of Rs. 300/- for delivery within Pakistan.
2. The bidders shall furnish earnest money in the shape of a pay order equivalent to 3% of the estimated value of their bids, in favor Chief Commissioner Inland Revenue, Regional Tax Office-I, Karachi.
