The applications shall be scrutinized and the tender documents will only be issued to the firms who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. The tenders must be received in the office of accepting officer by the 17 Feb 2025 till 1130 hours and will be opened at 1200 hours on the same date.

NOTE: -Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in a Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them

3 All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) in the relevant category and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.

4. Contractors borne on approved list of MES in Category 'A' and 'B' and also having experience of this type should only apply.

5. Desirous contractors may be present at the time of opening of tenders.

6. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.
