The Utility Stores Corporation of Pakistan (USCP) invites e-applications in accordance with the Public Procurement Rules, 2004, from Transporters / Transport Companies who are financially sound, registered with Federal Board of Revenue for Income Tax and GST (Registered) and who are on Active Tax Payer List (Income and Sales Tax) of the Federal Board of Revenue / relevant tax authorities at the time of opening of applications, for the transportation of stock of sugar to be lifted from Sugar Mills / Pepri Godown / KPT / Port Qaim Authority and other Godowns to Warehouse of USCP Zones / Regions as and when required basis through E-PADS. The open Framework Agreement will be signed for a period of one year with the selected bidders after bidding process on-demand / as and when required to be procured through subsequent call-off quotations with successful bidder(s). Only the prequalified applicants shall be entitled to participate in the procurement proceedings and the Open Framework Agreement will be signed between the procuring agency and the successful bidder(s).

Applications should be submitted electronically only through E-PADS. Manual submission of Applications is not allowed. Electronic Prequalification documents, containing detailed requirements, terms and conditions are available for the registered bidders on EPADS at www.eprocure.gov.pk.

Bids which are incomplete/not sealed/not signed/not stamped/late or submitted by other than specified mode will be rejected. The contract will be awarded to the most advantageous bid on lump sum contract basis region wise on lowest evaluated cost.

The electronic Pre-qualification documents prepared in accordance with the instructions in PQDs, must be submitted by using E-PADS on or before 17-02-2025 at 11:00 AM which will be opened on the same day at 11:30 PM through E-PADS. All interested Applicants / bidders must register themselves at E-PADS at http://eprocure.gov.pk.

In case of opening of bids falls on local/national/public holiday, the date of bid closing/opening shall be considered the next working day on the same time and venue.

Applications which are incomplete/not sealed/not signed/not stamped/late or submitted by other than specified mode will be rejected. The contract will be awarded to the most advantageous bid on region wise lump sum contract basis.
