- Bids should be submitted in sealed envelopes, delivered to the **O/o Director (C&P), Tarbela Dam Project** on as per above mentioned time / date and must be accompanied by a Bid Security for an amount not less than Two percent (2%) of the total Bid Price in the form of CDR in favor of GM&PD Tarbela Dam Project.
- Bids for LTV/HTV/Heavy Machinery will be opened on same the same day at **1130 Hrs. , 1200Hrs. And 1230 Hrs. Respectively** in the presence of the bidders or their authorized representatives who choose to attend the **O/o Director (C&P), Tarbela Dam Project**.
- This procurement will be carried out as per PPRA rules, 2004 (Single Stage One Envelope) as amended from time to time.
- The Employer reserves the rights to accept or reject any all bids / proposals at any time prior to acceptance of a bid or proposal.

Note: The Bidder must meet with the following Qualification Criteria:-

- General Experience of supply of goods/Spare Parts = 4 years
- Specific Experience= One or more similar nature assignment relating to supply of spare parts for Vehicles/Machinery, have substantially been completed with contract price up to Rs. 02 Million or more, during last 2 year.
- Bank statement for last one year. (Up to 31.12.2024).
- A certificate / affidavit that the firm is not black listed or debarred by any Government / Autonomous body.
