



Agriculture Department Diamer-Astore Division invites sealed tenders from relevant suppliers for supply of Hybrid Maize Seed for District Diamer and District Astore.

Tender documents containing details of items with specification, quantity as well as terms & conditions, will be available from the date of publication of this tender notice and will be issued during working days from 8:00 am to 4:00 pm by the Directorate of Agriculture Diamer-Astore Division Chilas after cash receipt of Rs. 2,000/tender document set as tender document fee. The sealed quotations should reach on 22<sup>nd</sup> May, 2024 at 11:00 AM to this office and the same will be opened on the same date at 11:30 AM in the office of the Director Agriculture Diamer-Astore Division Chilas in the presence of bidders or their representatives who care to be present.

**TERMS AND CONDITIONS:**

1. Only registered firms are eligible to participate in the bidding process, for supply of maize hybrid seed.
2. 3% Call Deposit Receipt (CDR) of the total offered bid amount as bid security issued by any scheduled bank including KCBL, in favor of Director Agriculture Diamer Astore Division must be attached.
3. Income tax and other duties (if any) will be deducted from the suppliers as per existing Government rules.
4. Supply orders will be issued immediately after finalization of tender process.
5. The quoted rates shall be valid up to 30.06.2024.
6. Un-realistic rates i.e. over or under estimated, conditional and incomplete bids shall be rejected straight away.
7. The committee reserves the right to reject any or all of the tenders after assigning any valid reason as per PPRA Rules.
