Invitation of Bids for Implementation Of Web Based (GIS) Enterprises Solution along with Mobile Application to Support HESCO Transmission HT/ LT Network

- 1. Hyderabad Electric Supply Company (HESCO), Hyderabad endeavoring to provide uninterrupted electric supply services to more than 1.23 Million valued consumers of 13 districts of Sindh Province.
- HESCO is performing the system studies for Grid & Transmission Network through PSS/E software for the purpose of Transmission System Expansion Planning. Besides this, HESCO is also using Arc GIS and SynerGEE Electric Software for GIS mapping of distribution network and analysis for the purpose of Rehabilitation / Planning of 11kV feeders.
- 3. HESCO intends to implement the web based automated system & 100% survey of Grid & Transmission network as well as 11kV feeders, LT Lines, Distribution Transformers, PVC & energy meters up-to consumer premises and its GIS mapping on turn-key basis. Those eligible firms who have executed similar assignments can submit Request for Proposal (RFP) along with the following information through EPAD tendering process.

Firm must be registered with PEC with valid Certificate.

- Minimum 03 (three) years relevant experience in field of GIS survey for power sector / other sector.
- Number and detail of similar projects, scope of works, contract value & client profile / name and assignments undertaken.

e. Organizational Chart including professional staff strength for relevant assignment.

Performance certificate from the clients served.

Registration copy of NTN, GST Income Tax (active tax payer) and Sindh Revenue Board etc.

Other terms & conditions are mentioned in Bidding Documents.

- E-bidding documents as per regulations, containing detailed terms and conditions specifications and requirements etc. are available for the registered bidder on EPADS at (www.eprocure.gov.pk).
- The electronic bids must be submitted by using EPADS on scheduled date & time. Manual bids, shall not be accepted. Electronic Bids will be opened on the same day.
- All E-bids must be accompanied by Bid security amount mentioned in bidding document in the favour of Chief Executive Officer HESCO, Hyderabad in the shape of "Bank Guarantee" /CDR/Banker Cheque from any schedule Bank of Pakistan, valid for 28 days beyond bid validity date. The bidders shall upload scanned copy of Bid Security on EPADS. Original Bid security must be submitted to the procuring Agency on or before the closing date & time of e-bids submission, failing which the e-bids shall rejected.
- The RFP procedure will be based upon "Single Stage Two Envelop" method as prescribed under PPRA
- Pre-bid meeting will be held on 24.06.2025 at 11:30 Hrs. Written queries and their response will be considered part of Bidding documents / RFP.
- Last date of proposal submission is 22.07.2025 at 11:00 Hrs the proposal will be opened on same day at 11:30Hrs. And financial bid shall be opened for those bidders, who successfully meet minimum passing technical score.
