4. Contractor born on approved list of MES in Category 'E' and above also having experience of this type should only apply.

5. Contractors who desire may be present at the time of opening of tenders.

6. The accepting office reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per par 33 (i) of PPRA Rules.
