1. Sealed bids/tenders should reach the office of undersigned on or before 11:00 AM 2nd November, 2022 and the tenders will be opened on the same date at 11:30 AM in the presence of bidders or their representative who care to be present.
2. Bidding will be conducted through single stage two envelopes procedure under PPRA rule 2004. The financial bids of only technically qualified bidders shall be opened.
3. All bidders are bound to quote bid rates according to specifications mentioned in the bidding document; otherwise, bid shall be rejected.
4. Call Deposit Receipt (CDR) @ of 3% of the total bid value issued by any scheduled bank as bid security in favor of the Director Agriculture Gilgit-Region, should be accompanied with financial bid while its copy be attached with the **technical bid**.
5. Income tax and other duties (if any) will be deducted from the suppliers as per existing government rules.
6. The quantity of items can be increased/decreased according to availability of funds.
