The Islamic Republic of Pakistan (hereinafter called “Borrower”) has received financing from the International Bank for Reconstruction and Development (IBRD) and International Development Association (IDA) (the “Bank”) in the form of a credit (hereinafter called credit”) toward the cost of the Khyber Pass Economic Corridor and intends to apply part of the proceeds toward payments under the contract(s) for Construction of Peshawar – Torkham Expressway (PTEX), including Southern Link Road.
2. The National Highway Authority (NHA), the Employer, intends to initially select Applicants for the contracts for Construction of Peshawar – Torkham Expressway (PTEX) on Design Build basis and Construction of Southern Link Road on Design Build basis under two lots:
 - Lot-1: Construction of Peshawar – Torkham Expressway (PTEX) on Design Build basis.
 - Lot-2: Construction of Southern Link Road on Design Build basis.
3. NHA now invites applications for Initial Selection for the above contracts. Interested applicants may apply for one or both lots. Evaluation of the applications shall be carried out separately for each lot, however, in order to be initially selected for both lots the applicant will have to meet the Initial Selection Criteria and Requirements of both lots on aggregate basis as specified in the Initial Selection Document.
4. Initial Selection will be conducted through the procedures as specified in the World Bank’s Procurement Regulations for IPF Borrowers dated July 2016, revised November 2017 (“Procurement Regulations”), which can be found at www.worldbank.org and is open to all eligible Applicants as defined in the Procurement Regulations.

5. Interested eligible Applicants may obtain further information from the National Highway Authority at the address below during office hours [0800 to 1600 hours].
6. A complete set of **Initial Selection documents** in English may be purchased by interested Applicants upon the submission of a written application to the address below upon payment of a nonrefundable fee of PKR 10,000 (Pakistan Rupees Ten Thousand) in favor of National Highway Authority. The method of payment will be electronic wire transfer or cash deposit to the Employer's bank account specified below or by Pay Order/Demand Draft in favor of National Highway Authority.
 - The documents may be collected in person at the address mentioned below or may be delivered for overseas delivery. No liability will be accepted for loss in transit or late delivery.
 - The eligible applicants also have the option to download the document at no cost from NHA website i.e., www.nha.gov.pk. Eligible applicants opting to download the document from NHA website shall inform NHA in writing at the address given below failing which NHA shall not be responsible if the applicant does not receive clarifications and amendments, if any. In case of any discrepancy between the downloaded document and hard copy, the latter shall prevail.
7. Applications for Initial Selection should be submitted in clearly marked envelopes and delivered to the address below by **1130 hours** on **12th October, 2022**. Late applications may be rejected. The applications will be opened at **1200 hours** on the same day in NHA Auditorium, HQ, Islamabad.
