RE-TENDER NOTICE

Online/ Electronic tenders are invited through web portal <https://etender.mlc.gov.pk> accompanied by earnest money in shape of deposit-at-call, in favour of Executive Officer, Walton Cantonment based on MES Schedule of Rates 2021 (as amended up-to-date) for the following works to be executed during the current fiscal year 2022-2023. - 1) Interested bidders can only submit their bids online through e-Tender Portal of ML&C Dept (<https://etender.mlc.gov.pk>).
- 2) Contractors having valid NTN No, STRN No and PEC Registration of relevant codes are eligible to apply. In case bidders have applied for renewal of PEC only those bidders will be eligible who has renewed PEC license till 30th June 2022 will be accepted only.
- 3) The cutoff time for submission of online bids will be 1100 hrs dated 23 / 11 / 2022 and shall be opened on same day at 1530hrs electronically on the portal. The contractors will be able to see the comparative statement online.
- 4) The bidders are required to submit a demand draft as mentioned against each of bid price as earnest money / security in shape of Call Deposit only of successful bidder will be refunded after expiry of warranty period. No bond other than CDR shall be accepted.
- 5) E-tenders without attachment of call deposit/ bid bond in favour of the undersigned equal to the earnest money will be rejected.
- 6) The successful contractor shall enter into a prescribed agreement (at their own cost on non-judicial stamp paper) with the CB Walton within 07 days of issuance of acceptance letter.
- 7) The issuance of work order shall be subject to approval from Board.
- 8) The validity of tender rates shall be upto 180 days as per PPR / PEC Rules.
- 9) In case if the lowest bid is less than reasonable rates (10% above/below than the ruling %age as circulated by E-in-C's Branch letter No.2005/22/A/Ruling %age/PP&W/E2 dated 23rd Oct 2020), the lowest bidder shall have to deposit standing security 10% bid amount (refundable after successful completion of the work) in the shape of Call Deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and tender will be cancelled.
- 10) The Cantonment Board reserves the rights to demand the analysis of quoted rates to check their reasonability and workability.

The Cantonment Board/ Executive Officer reserve the right to reject the tender as per PPRA's Rule No.33 (I) due to any reason thereof.

The CDRs uploaded online shall be deposited in the office on the same day of opening of bids. In case of failure the bids submitted will be rejected and proceedings will be started against the bidder for blacklisting.

Any information regarding the e-tender can be obtained from the office of undersigned during office hours. Furthermore, user guidance tutorial has been uploaded on the portal.
