The bidder must be on the Active Taxpayer List (ATC) of FBR.

Bidding documents will be available from the office of undersigned up to 04-11-2022, during office hours (9.00 AM to 5.00 PM). However, copy of the bidding documents is also available for information only on the website of Public Procurement Regulatory Authority (PPRA) Pakistan and Ministry of National Health Services, Regulations and Coordination (<http://www.nhsr.gov.pk/>).

Single Stage – Two Envelopes bidding procedure as per Rule 36 (b) of Public Procurement Rules 2004 will be adopted.

Sealed Bids must be delivered at the address given below on or before 07-11-2022 by 11:00 AM. Technical Proposals of the participated bidders will be opened on same day at 11.30AM.

Bid security @ 2% of the estimated price in the shape of Pay Order / Bank Draft from any scheduled bank of Pakistan in favor of Project Director must be provided along with the financial bid. Late bids will be rejected. Technical Bids will be opened in the presence of the bidders/ representatives who choose to be present on at 11:30AM. Financial bids of only technically qualified bidders will be opened on the date and time to be announced later. The quantity of items can be increased/ decrease subject to availability of budget.

The bidders are requested to quote their best and final prices as no negotiations on the prices are allowed.

The procuring agency reserves the right under Rule 33 of PPR-2004 to accept/ reject all the bids without assigning any reason prior to the acceptance of bids.
