In order to be considered, the tender must be accompanied by a Tender / Bid Security not less than 2% of the quoted bid price for pre-qualified firms and 5% for non pre-qualified firms, in the favour of Chief Engineer (Dev) PMU, HESCO, Hyderabad in the shape of "Bank Guarantee" / CDR/ Banker Cheque from any Scheduled Bank of Pakistan, valid for 30 days beyond bid validity date.
- 4. The territorial jurisdiction of the litigation shall be the District Head Quarter where the head office of HESCO is located i.e Hyderabad District.
- 5. The tender shall remain open for acceptance for 90-days or as per bidding document.
