

3. The firm will submit Bid Security amounting equal to 2% of value of bid (maximum PKR 2 Million) as Earnest Money (Including all taxes) in the shape of Bank Draft/ CDR drawn in favour of “**DDO MAG’s Office, Kashmir Road, Rawalpindi**.”
