# A. INTRODUCTION

1. Scope of Bid	1.1	The Procuring Agency (PA), as indicated in the <b>Bid Data</b> <b>Sheet</b> (BDS) invites Bids for the provision of Goods as specified in the BDS and <b>Section V - Technical</b> <b>Specifications &amp; Schedule of Requirements</b> . The successful Bidders will be expected to deliver the goods within the specified period and timeline(s) as stated in the <b>BDS</b> .
2. Source of Funds	2.1	Source of funds is referred in Clause-2 of Invitation for Bids.
3. Eligible Bidders	3.1	A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract. The appointment of Lead Member in the joint venture,
		consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Proguring Agongy
	3.3	Procuring Agency. Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.
	3.4	Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be

	evaluated (or post qualified if required) with respect to
	its contribution only, and the responsibilities of each
	party shall not be substantially altered without prior
	written approval of the Procuring Agency and in line

3.5	The invitation for Bids is open to all prospective
	supplier, manufacturers or authorized agents/dealers
	subject to any provisions of incorporation or licensing by
	the respective national incorporating agency or statutory
	body established for that particular trade or business.
3.6 .	Foreign Bidders must be locally registered with the
	appropriate national incorporating body or the statutory

3.10	Bidders shall provide such evidence of their continued eligibility to the satisfaction of the Procuring Agency, as the Procuring Agency shall reasonably request.
3.11	Bidders shall submit proposals relating to the nature, conditions and modalities of sub-contracting wherever the sub-contracting of any elements of the contract amounting to the more than ten (10) percent of the Bid

		price is envisaged.
4. Eligible Goods and Related Services	4.1	All goods and related services to be supplied under the contract shall have their origin in eligible source countries, and all expenditures made under the contract will be limited to such goods and services. For purpose of this Bid, ineligible countries are stated in the section-4 titled as "Eligible Countries".
	4.2	For purposes of this Clause, "origin" means the place where the goods are mined, grown, cultivated, produced, manufactured, or processed, or through manufacture, procession, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its imported components or the place from where the related services are/to be supplied.
	4.3	The nationality of the supplier that supplies, assembles, distributes, or sells the goods and services shall not determine the origin of the goods.
	4.4	To establish the eligibility of the Goods and the related services, Bidders shall fill the country of origin declarations included in the Form of Bid.
	4.5	If so required in the <b>BDS</b> , the Bidder shall demonstrate that it has been duly authorized by the manufacturer of the goods to deliver in Pakistan (or in respective country in case of procurement by the Pakistani Missions abroad), the goods indicated in its Bid.
5. One Bid per Bidder	5.1	A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.
	5.2	No bidder can be a sub-contractor while submitting a Bid individually or as a member of a joint venture in the same Bidding process.
	5.3	A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.
6. Cost of Bidding	6.1	The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Procuring Agency shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

# SECTION V: SCOPE OF SERVICES

#### GROUP HEALTH INSURANCE SCOPE OF SERVICES

#### 1. <u>MEDICAL INSURANCE:</u>

#### (a) General:

Medical care facilities shall be available to all confirmed employees (and family members) who completed their probation period of the Fund. Services of an Insurance Company are intended to be hired who shall be having a panel of major hospitals in all the provinces and federal capital in Pakistan for providing health insurance to the employees and their family members, of the Fund:

#### (b) Indoor Treatment Including Hospitalization:

This will cover all types of major ailments and physical injuries including preexisting, to an employee or his/her family members requiring treatment through admission and stay in the hospitals or prolonged preventive Medicare under advice by the specialist. Dental treatment requiring hospitalization shall also be included in this category. Such treatment shall also include hospitalization of less than 24 hours if required for carrying out diagnostic tests, treatment or minor surgery.

Health insurance shall include the following benefits;

- i. All in-hospital accommodation, treatment and services
- ii. Doctors' Visits
- iii. In-patient treatment / drugs expenses
- iv. ICU Charges
- v. Charges for all surgical procedures
- vi. Pre-hospital diagnosis;
- vii. Provides reimbursement of expenses for diagnosis outside the hospital and can be utilized up to 30 days before admission into the hospital
- viii. Post hospital follow-up treatment;
  - ix. Provides reimbursement for post hospitalization follow-up and can be utilized up to 30 days after discharge
  - x. Local ambulance services
  - xi. Day care Surgery (50% enhancement of H&R)
- xii. Diagnostic tests, consultations and Medicines

- xiii. Accidental, Emergency Medical Services
- xiv. Any other medical facility/treatment as per medical insurance policy.
- xv. Pre-existing diseases of employees as well as their dependents may be covered in the insurance.
- xvi. Male children below the age of 25 years and unmarried female children may be covered
- xvii. Parents up to age of 80 years.
- xviii. 50% enhancement in H& R limit in case of RTA.
  - xix. Four weeks pre & post hospitalization cost of diagnostic test, consultation and medication may be covered.
  - xx. Day-care surgeries may be covered
  - xxi. local road ambulance for emergencies may be covered.
- xxii. Emergency Dental treatment may be covered.
- xxiii. Covid-19 coverage.
- xxiv. Organ transplant/prosthetic treatments may be covered (excluding cost of implant).
- xxv. Hospitalization limit per person per annum.
- xxvi. Maximum coverage of Panel hospitals.
- xxvii. Major medical care/dread disease (enhanced coverage upto Rs. 1,200,000 in H&R limit).
- xxviii. Contract with the Insurance provider may be awarded for two years' subject to satisfactory performance in year one.
  - xxix. Profit Sharing

## (c) <u>Dental Treatment:</u>

This will include treatment of all types of dental ailments except provision of dentures, braces, cosmetic scaling and orthodental treatment, tooth implants, gold/silver crown/bridges and gold inlays. Dental treatment can be availed from any Medical and Dental Care Unit that will be on the panel of the Insurance Company.

#### 2. <u>REIMBURSABLE MEDICAL ATTENTION AND TREATMENT:</u>

Every Employee and his/her Family members shall be entitled to Medical Attention and treatment if such Medical Attention or treatment is essential.

#### 3. <u>ENROLMENT OF APPROVED HOSPITALS:</u>

The Fund and the Insurer may approve any hospital, clinic, maternity home, pathological laboratory, radiological laboratory or any other institution for Medical Attention and treatment of, and any medical store for supply of medicines to the Employee and Family members, with mutual consent/ agreement.

#### 4. <u>Removal Of Approved Hospital From The Approved Panel:</u>

The Insurer (in consultation with the Fund) shall terminate arrangements made with any hospital, clinic, maternity home or other institutions for Medical Attention and treatment of Fund's Employees and their Families, if Fund reports any unsatisfactory services of any entity.

#### 5. <u>ENTITLEMENT OF ACCOMMODATION IN APPROVED HOSPITALS:</u>

- a) An Employee or his/her Family shall be entitled to such accommodation in a hospital, as per limits given hereunder at Sr No: 9 viz. Limits, or as may be amended by the Fund from time to time.
- b) An Employee or his/her Family member, if provided accommodation of a class lower than that of entitlement, in an Approved Hospital on account of non-availability of accommodation, shall not be entitled to claim payment of difference between charges for such class of accommodation. However, that shall not be a preferred mode and insurer should be ensuring availability of rooms as per entitlement of employee.
- c) An Employee or Family member, if provided accommodation of a class higher than entitlement in an Approved Hospital, shall her/himself pay to the hospital difference between the charges for such class of accommodation and his entitlement.

## 6. MEDICAL ATTENTION ON TOUR:

An Employee on tour to a place where there is no approved Hospital may arrange for Medical Attention and treatment from any registered medical practitioner or in any hospital at that place and, on production in original of the prescriptions, invoices with receipts for payment and cash memos, may claim reimbursement of expenses on such Medical Attention and treatment. Such reimbursements shall be covered by the Insurance Company in its Medical/Health Insurance Policy.

# 7. <u>MEDICAL ATTENTION DURING LEAVE:</u>

An Employee on leave or his/her Family visiting a place where there is no approved Hospital may arrange for Medical Attention and treatment from any hospital at that place and, on production in original of the prescriptions, invoices with receipts for payment and cash memos, may claim reimbursement of expenses on such Medical Attention and treatment. Such reimbursements shall be covered by the Insurance Company in its Medical/Health Insurance Policy.

# 8. <u>Reimbursement Of Medical Expenses In Emergency Cases/ Medical</u> <u>Attention during visit/Leave:</u>

All medical emergencies shall be managed in Fund's medical cover procedures. It will be built in the insurance cover that such reimbursements could be covered by

the Insurance Company.

- 8.1 Claims for reimbursement of cost of medicines prescribed by an Approved Hospital for treatment during hospitalization but not available with the Approved Hospital, shall be entertained only when accompanied by:
  - **a)** The concerned Doctor's prescription for the required medicines.
  - b) Cash memos evidencing purchase of medicines verified by the claimant and countersigned by General Manager, Support Services Group.
  - c) Discharge Certificate from the concerned Department of the approved Hospital.
- 8.2 In cases of treatment of patients at places other than the place of posting of the Employee, treatment only from well reputed hospitals shall be received.
- 8.3 Insurer shall reimburse the expenses which an employee and or his/her dependents, shall incur against emergency cases or medical attention during visits / leaves for acquiring health services from other than the panel hospitals, clinic, maternity home or other institutions.
- 8.4 All such claims shall be settled within 12 days of their receipt at Insurer's office at Islamabad /Rawalpindi.
- 8.5 Claims of Reimbursement shall be verified by GM (Support Services Group) of NDRMF and shall be lodges with the Insurer on monthly basis.

## 9. <u>LIMITS:</u>

There will be only one category of Employees' Health Insurance. The annual health insurance benefit for each employee shall be as follows, which is however, subject to revision by the Fund as and when deemed appropriate. In such case, Insurer shall be consulted as if the revision could impact the policy premiums.

# 10. <u>MEDICAL CARE:</u>

Following medical care shall be entitled to the employees of the Fund and their dependents:

## 10.1 HOSPITAL CARE:

Medical expenses shall include:

- (i) Daily room and board charges, operation theater charges, surgeons fees, anesthetist fee, consultant's fee, medicines and drugs, diagnostic tests, blood and oxygen supplies, all Lab test, miscellaneous charges(local road ambulance charges), etc.
- (ii)The expenses incurred outside the hospital will also cover under Pre and Post Hospitalization of 30 days each for same disease irrespective of checkups from different Doctor's/hospitals including diagnostic tests, consultation & medicines.
- (iii) Coverage for New born babies soon after birth if required.

## 10.2 <u>MAJOR MEDICAL CARE/DREAD DISEASE THROUGH HOSPITALIZATION (ENHANCED</u> COVERAGE UPTO Rs. 1,200,000 in H&R LIMIT)

Following medical treatment shall be allowed:

- (i) Management of acute myocardial infarction(heart attack)
- (ii) Coronary artery heart by-pass,

- (iii) Cerebro Vascular Accidents (CVA Stroke)
- (iv) Management of all type of Malignancies cancer including chemotherapy & radiation,
- (v) Management of Renal Failure
- (vi) Major transplant
- (vii) Major burns
- (viii) Liver Cirrhosis
- (ix) Paralysis
- (x) Brain Tumor
- (xi) Hepatitis "B" & "C" (Interferon Injections)
- (xii) Maternity Care (Maternity & Newborn Child Coverage) It will include Gynecologist fee, labor room/ operation theater charges, anesthetist fee, miscarriage, medicines, diagnostic tests, baby nursing care, circumcision of the baby boy, daily room rent charges, antenatal and postnatal hospitalizations, D&C and D&E, miscellaneous charges. It will also cover prenatal nine month & postnatal 30 days, Child Birth, Complicated delivery, Legal Abortion and Miscarriages.
- (xiii) Dental Care (except dentures, braces, cosmetic scaling, orthodental treatment, tooth implants, gold/silver crowning/bridges & gold inlays)
- (xiv) Multiple Sclerosis
- (xv) Deafness
- (xvi) Blindness
- (xvii) Covid

## **10.3** Specialized Investigations

Following investigations shall be allowed:

- (i) Thallium Scan
- (ii) Angiography
- (iii) Endoscope and related tests
- (iv) MRI and related tests
- (v) CT Scan, HRCT (Chest), ETT & Echo
- (vi) Biopsy & Cancer diagnosis tests
- (vii) Gastroscopy
- (viii) Mammography
- (ix) Colonoscopy
- (x) Incision & Drainage
- (xi) Barium Enema etc.
- (xii) Carotid Doppier
- (xiii) EEG
- (xiv) EMG
- (xv) HAULTER 'S Monitoring.

## **10.4 DAYCARE SURGERIES**

Following charges during in patient hospitalization (i.e necessary medical treatment/Surgical procedure that requires the patient to occupy a hospital bed but do not require an overnight stay) in connection with daycare surgeries/Procedure, shall be allowed:

- (i) Eye surgery including Intraocular lens
- (ii) Treatment of fractures, lacerated wounds & Minor operations
- (iii) Local road ambulance charges for emergency only
- (iv) Emergency Dental treatment due to accidental injuries within 48 hours
- (v) Emergency room treatment for accident/non-accident cases.
- (vi) Specialized Investigation.
- (vii) Lithotripsy (Kidney Stone)
- (viii) Tonsillectomy
- (ix) Adenoidectomy
- (x) Varicose Veins
- (xi) Dialysis
- (xii) Chemotherapy
- (xiii) Radiotherapy

#### 11. EXCLUSIONS

Fund's medical reimbursement policy does not cover claims directly or indirectly from or consequent upon:

- a. Treatment of injuries resulting from participation in war, invasion, or revolution.
- **b.** Any increase in expenses incurred for treatment on account of the insured member being admitted to a more expensive room than allowed by his daily room and board sub-limit.
- c. General health check-ups and immunizations.
- d. Congenital defects and deformities (of any nature whatsoever).
- e. Treatment relating to infertility; however, initial laboratory tests prescribed by specialist doctors to verify infertility can be disbursed. Nevertheless, the treatment of temporary (secondary) infertility due to inconsistency of hormones shall be reimbursed upon certification by the consulting doctor,
- f. Costs resulting from self-inflicted injury, suicide, abuse of alcohol, drug addiction, nervous or mental disorder, Sleep disorders, psychotic, mental or nervous disorders and treatment of sexuality-transmitted diseases.

- g. Acquired immune deficiency syndrome (AIDS), AIDS related complex syndrome (ARCS) and all diseases caused by and or related to virus HIV positive,
- **h.** Cosmetic or plastic surgery unless necessitated by an accidental injury occurred during the employment period,
- i. Any physical or mental condition, which originated prior to the effective date of appointment on regular contract and completion of probation period,
- j. Sports/Recreational injuries and/or complications arising thereof,
- **k.** Contact lenses (any type without surgery). Laser keratotomy (Laser corneal surgery for correction of refractive error to get rid of glasses),
- 1. Skin care tonic and lotions apart from those prescribed for known skin ailments,
- m. Weight reduction surgeries/drugs,
- **n**. Food supplements, vitamins, or any type of drugs used to enhance sexual capabilities,
- **o.** Any person/dependent carried through Government department or any other source should not be able to claim,
- **p.** Any high potency injectable antibiotic for more than one day on OPD basis.
- **q.** For medical treatment obtained outside Pakistan, we will reimburse the amount we would pay a local Network Hospital for similar treatment.
- r. Charges for telephone, guest meals, tissue papers etc.
- s. Charges for durable medical appliances such as Nebulizers, Glucometers, etc.
- t. Charges incurred by an insured employee or his/her dependent as an organ donor.
- **12.** <u>Eligibility:</u> Employees and their dependents qualifying following ages shall be entitled for the coverage under Medical Insurance Policy:
  - a) NDRMF Employees without any age limits including Pre-Existing diseases/Conditions.
  - b) Parents' without any age limits.
  - c) Spouse without any age limit.
  - d) Un-married children (both male & female), up to the age of 21 Years.

e) Any nature of permanent disability without any age limits of an employee, and his/her dependents.

## 13. <u>Dependents:</u>

Dependents are hereby defined for the purpose of submission of medical claims as Wife/Husband, unmarried children upto the age of twenty-one (21) years and the parents of the employee. Female employees whether married or unmarried are also entitled to claim reimbursement of claims for her parents. A declaration form shall be prescribed and made available.
