A. INTRODUCTION

Scope of Bid</p>	<p>1.1</p>	<p>The Procuring Agency (PA), as indicated in the Bid Data Sheet (BDS) invites Bids for the provision of Goods as specified in the BDS and Section V - Technical Specifications & Schedule of Requirements. The successful Bidders will be expected to deliver the goods within the specified period and timeline(s) as stated in the BDS.</p>
<p>2. Source of Funds</p>	<p>2.1</p>	<p>Source of funds is referred in Clause-2 of Invitation for Bids.</p>
<p>3. Eligible Bidders</p>	<p>3.1</p>	<p>A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract.</p>
	<p>3.2</p>	<p>The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency.</p>
	<p>3.3</p>	<p>Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.</p>
	<p>3.4</p>	<p>Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be</p>

		evaluated (or post qualified if required) with respect to its contribution only, and the responsibilities of each party shall not be substantially altered without prior written approval of the Procuring Agency and in line with any instructions issued by the Authority.
	3.5	The invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national incorporating agency or statutory body established for that particular trade or business.
	3.6 .	Foreign Bidders must be locally registered with the appropriate national incorporating body or the statutory body, before participating in the national/international competitive tendering with the exception of such procurements made by the foreign missions of Pakistan. For such purpose the bidder must have to initiate the registration process before the bid submission and the necessary evidence shall be submitted to the procuring agency along with their bid, however, the final award will be subject to the complete registration process.
	3.7	<p>A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidders may be considered to have a conflict of interest with one or more parties in this Bidding process, if they:</p> <ul style="list-style-type: none"> a) are associated or have been associated in the past, directly or indirectly with a firm or any of its affiliates which have been engaged by the Procuring Agency to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of the goods to be purchased under this Invitation for Bids. b) have controlling shareholders in common; or c) receive or have received any direct or indirect subsidy from any of them; or d) have the same legal representative for purposes of this Bid; or e) have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or

		<p>influence on the Bid of another Bidder, or influence the decisions of the Procuring Agency regarding this Bidding process; or</p> <p>f) Submit more than one Bid in this Bidding process.</p>
	3.8	<p>A Bidder may be ineligible if –</p> <p>(a) he is declared bankrupt or, in the case of company or firm, insolvent;</p> <p>(b) payments in favor of the Bidder is suspended in accordance with the judgment of a court of law other than a judgment declaring bankruptcy and resulting (in accordance with the national laws) in the total or partial loss of the right to administer and dispose of its property;</p> <p>(c) legal proceedings are instituted against such Bidder involving an order suspending payments and which may result, in accordance with the national laws, in a declaration of bankruptcy or in any other situation entailing the total or partial loss of the right to administer and dispose of the property;</p> <p>(d) the Bidder is convicted, by a final judgment, of any offence involving professional conduct;</p> <p>(e) the Bidder is blacklisted and hence debarred due to involvement in corrupt and fraudulent practices, or performance failure or due to breach of bid securing declaration.</p> <p>(f) The firm, supplier and contractor is blacklisted or debarred by a foreign country, international organization, or other foreign institutions for the period defined by them.</p>
	3.9	<p>Bidders shall provide to the Procuring Agency evidence of their eligibility, proof of compliance with the necessary legal requirements to carry out the contract effectively.</p>
	3.10	<p>Bidders shall provide such evidence of their continued eligibility to the satisfaction of the Procuring Agency, as the Procuring Agency shall reasonably request.</p>
	3.11	<p>Bidders shall submit proposals relating to the nature, conditions and modalities of sub-contracting wherever the sub-contracting of any elements of the contract amounting to the more than ten (10) percent of the Bid</p>

		price is envisaged.
4. Eligible Goods and Related Services	4.1	All goods and related services to be supplied under the contract shall have their origin in eligible source countries, and all expenditures made under the contract will be limited to such goods and services. For purpose of this Bid, ineligible countries are stated in the section-4 titled as “Eligible Countries”.
	4.2	For purposes of this Clause, “origin” means the place where the goods are mined, grown, cultivated, produced, manufactured, or processed, or through manufacture, procession, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its imported components or the place from where the related services are/to be supplied.
	4.3	The nationality of the supplier that supplies, assembles, distributes, or sells the goods and services shall not determine the origin of the goods.
	4.4	To establish the eligibility of the Goods and the related services, Bidders shall fill the country of origin declarations included in the Form of Bid.
	4.5	If so required in the BDS , the Bidder shall demonstrate that it has been duly authorized by the manufacturer of the goods to deliver in Pakistan (or in respective country in case of procurement by the Pakistani Missions abroad), the goods indicated in its Bid.
5. One Bid per Bidder	5.1	A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.
	5.2	No bidder can be a sub-contractor while submitting a Bid individually or as a member of a joint venture in the same Bidding process.
	5.3	A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.
6. Cost of Bidding	6.1	The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Procuring Agency shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

	<p>7.2</p>	<p>The number of copies to be completed and returned with the Bid is specified in the BDS.</p>
	<p>7.4</p>	<p>The Procuring Agency is not responsible for the completeness of the Bidding Documents and their addenda, if they were not obtained directly from the Procuring Agency or the signed pdf version from downloaded from the website of the Procuring Agency. However, Procuring Agency shall place both the pdf and same editable version to facilitate the bidder for filling the forms.</p>
	<p>7.5</p>	<p>The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all the information required in the Bidding Documents will be at the Bidder’s risk and may result in the rejection of his Bid.</p>
<p>8. Clarification of Bidding Documents</p>	<p>8.1</p>	<p>A prospective Bidder requiring any clarification of the Bidding Documents may notify the Procuring Agency in writing or in electronic form that provides record of the content of communication at the Procuring Agency's address indicated in the BDS.</p>
	<p>8.2</p>	<p>The Procuring Agency will within three (3) working days after receiving the request for clarification, respond in writing or in electronic form to any request for</p>

		clarification provided that such request is received not later than three (03) days prior to the deadline for the submission of Bids as prescribed in ITB 23.1 . However, this clause shall not apply in case of alternate methods of Procurement.
	8.3	<p>Copies of the Procuring Agency's response will be forwarded to all identified Prospective Bidders through an identified source of communication, including a description of the inquiry, but without identifying its source.</p> <p>In case of downloading of the Bidding Documents from the website of PA, the response of all such queries will also be available on the same link available at the website.</p>
	8.4	Should the Procuring Agency deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under ITB 9 .
	8.5	If indicated in the BDS , the Bidder's designated representative is invited at the Bidder's cost to attend a pre-Bid meeting at the place, date and time mentioned in the BDS . During this pre-Bid meeting, prospective Bidders may request clarification of the schedule of requirement, the Evaluation Criteria or any other aspects of the Bidding Documents.
	8.6	Minutes of the pre-Bid meeting, if applicable, including the text of the questions asked by Bidders, including those during the meeting (without identifying the source) and the responses given, together with any responses prepared after the meeting will be transmitted promptly to all prospective Bidders who have obtained the Bidding Documents. Any modification to the Bidding Documents that may become necessary as a result of the pre-Bid meeting shall be made by the Procuring Agency exclusively through the use of an Addendum pursuant to ITB 9. Non-attendance at the pre-Bid meeting will not be a cause for disqualification of a Bidder.
9. Amendment of Bidding Documents	9.1	Before the deadline for submission of Bids, the Procuring Agency for any reason, whether at its own initiative or in response to a clarification requested by a

		prospective Bidder or pre-Bid meeting may modify the Bidding Documents by issuing addenda.
	9.2	<p>Any addendum issued including the notice of any extension of the deadline shall be part of the Bidding Documents pursuant to ITB 7.1 and shall be communicated in writing or in any identified electronic form that provide record of the content of communication to all the bidders who have obtained the Bidding Documents from the Procuring Agency. The Procuring Agency shall promptly publish the Addendum at the Procuring Agency's web page identified in the BDS:</p> <p>Provided that the bidder who had either already submitted their bid or handed over the bid to the courier prior to the issuance of any such addendum shall have the right to withdraw his already filed bid and submit the revised bid prior to the original or extended bid submission deadline.</p>

Supporting documents and printed literature furnished by the Bidder may be in another language provided they are accompanied by an accurate translation of the relevant pages in the English language unless specified in the BDS , in which case, for purposes of interpretation of the Bidder, the translation shall govern.
11. Documents and Sample(s) Constituting the Bid	11.1	<p>The Bid prepared by the Bidder shall constitute the following components: -</p> <p>a) Form of Bid and Bid Prices completed in accordance with ITB 14 and 15;</p>

	11.4	<p>Where it is not possible to avoid using a propriety article as a sample, a Bidder shall make it clear that the propriety article is displayed only as an example of the type or quality of the goods being Bided for, and that competition shall not thereby be limited to the extent of that article only.</p>
	11.5	<p>Samples made up from materials supplied by a Procuring Agency shall not be returned to a Bidder nor shall a Procuring Agency be liable for the cost of making them.</p>
	11.6	<p>All samples produced from materials belonging to an unsuccessful Bidder shall be kept by the Procuring Agency till thirty (30) days from the date of award of contract or exhaust of all the grievance forums (including those pending at Authority's Level or in some Court of Law).</p>
<p>12. 	12.4	The Bidder shall also furnish a list giving full particulars, including available sources and current prices of goods, spare parts, special tools, etc., necessary for the proper and continuing functioning of the Goods during the period specified in the BDS following commencement of the use of the goods by the Procuring Agency.
	12.5	For purposes of the commentary to be furnished pursuant to ITB 12.3(c) above, the Bidder shall note that standards for workmanship, material, and equipment, as well as references to brand names or catalogue numbers designated by the Procuring Agency in its Technical Specifications, are intended to be descriptive only and not restrictive. The Bidder may substitute alternative standards, brand names, and/or catalogue numbers in its Bid, provided that it demonstrates to the Procuring Agency's satisfaction that the substitutions ensure substantial equivalence to those designated in the Technical Specifications.
	12.6	The required documents and other accompanying documents must be in English. In case any other language than English is used the pertinent translation into English shall be attached to the original version.
13. Documents Establishing Eligibility and Qualification of the Bidder	13.1	Pursuant to ITB 11 , the Bidder shall furnish, as part of its Bid, all those documents establishing the Bidder's eligibility to participate in the bidding process and/or its qualification to perform the contract if its Bid is accepted.
	13.2	The documentary evidence of the Bidder's eligibility to Bid shall establish to the satisfaction of the Procuring Agency that the Bidder, at the time of submission of its bid, is from an eligible country as

GROUP HEALTH INSURANCE
SCOPE OF SERVICES

1. MEDICAL INSURANCE:

(a) General:

Medical care facilities shall be available to all confirmed employees (and family members) who completed their probation period of the Fund. Services of an Insurance Company are intended to be hired who shall be having a panel of major hospitals in all the provinces and federal capital in Pakistan for providing health insurance to the employees and their family members, of the Fund:

(b) Indoor Treatment Including Hospitalization:

This will cover all types of major ailments and physical injuries including pre-existing, to an employee or his/her family members requiring treatment through admission and stay in the hospitals or prolonged preventive Medicare under advice by the specialist. Dental treatment requiring hospitalization shall also be included in this category. Such treatment shall also include hospitalization of less than 24 hours if required for carrying out diagnostic tests, treatment or minor surgery.

Health insurance shall include the following benefits;

- i. All in-hospital accommodation, treatment and services
- ii. Doctors' Visits
- iii. In-patient treatment / drugs expenses
- iv. ICU Charges
- v. Charges for all surgical procedures
- vi. Pre-hospital diagnosis;
- vii. Provides reimbursement of expenses for diagnosis outside the hospital and can be utilized up to 30 days before admission into the hospital
- viii. Post hospital follow-up treatment;
- ix. Provides reimbursement for post hospitalization follow-up and can be utilized up to 30 days after discharge
- x. Local ambulance services
- xi. Day care Surgery (50% enhancement of H&R)
- xii. Diagnostic tests, consultations and Medicines

- xiii. Accidental, Emergency Medical Services
- xiv. Any other medical facility/treatment as per medical insurance policy.
- xv. Pre-existing diseases of employees as well as their dependents may be covered in the insurance.
- xvi. Male children below the age of 25 years and unmarried female children may be covered
- xvii. Parents up to age of 80 years.
- xviii. 50% enhancement in H& R limit in case of RTA.
- xix. Four weeks pre & post hospitalization cost of diagnostic test, consultation and medication may be covered.
- xx. Day-care surgeries may be covered
- xxi. local road ambulance for emergencies may be covered.
- xxii. Emergency Dental treatment may be covered.
- xxiii. Covid-19 coverage.
- xxiv. Organ transplant/prosthetic treatments may be covered (excluding cost of implant).
- xxv. Hospitalization limit per person per annum.
- xxvi. Maximum coverage of Panel hospitals.
- xxvii. Major medical care/dread disease (enhanced coverage upto Rs. 1,200,000 in H&R limit).
- xxviii. Contract with the Insurance provider may be awarded for two years' subject to satisfactory performance in year one.
- xxix. Profit Sharing

(c) Dental Treatment:

This will include treatment of all types of dental ailments except provision of dentures, braces, cosmetic scaling and orthodontal treatment, tooth implants, gold/silver crown/bridges and gold inlays. Dental treatment can be availed from any Medical and Dental Care Unit that will be on the panel of the Insurance Company.

2. REIMBURSABLE MEDICAL ATTENTION AND TREATMENT:

Every Employee and his/her Family members shall be entitled to Medical Attention and treatment if such Medical Attention or treatment is essential.

3. ENROLMENT OF APPROVED HOSPITALS:

The Fund and the Insurer may approve any hospital, clinic, maternity home, pathological laboratory, radiological laboratory or any other institution for Medical Attention and treatment of, and any medical store for supply of medicines to the Employee and Family members, with mutual consent/ agreement.

4. REMOVAL OF APPROVED HOSPITAL FROM THE APPROVED PANEL:

The Insurer (in consultation with the Fund) shall terminate arrangements made with any hospital, clinic, maternity home or other institutions for Medical Attention and treatment of Fund's Employees and their Families, if Fund reports any unsatisfactory services of any entity.

5. ENTITLEMENT OF ACCOMMODATION IN APPROVED HOSPITALS:

- a) An Employee or his/her Family shall be entitled to such accommodation in a hospital, as per limits given hereunder at Sr No: 9 viz. Limits, or as may be amended by the Fund from time to time.
- b) An Employee or his/her Family member, if provided accommodation of a class lower than that of entitlement, in an Approved Hospital on account of non-availability of accommodation, shall not be entitled to claim payment of difference between charges for such class of accommodation. However, that shall not be a preferred mode and insurer should be ensuring availability of rooms as per entitlement of employee.
- c) An Employee or Family member, if provided accommodation of a class higher than entitlement in an Approved Hospital, shall her/himself pay to the hospital difference between the charges for such class of accommodation and his entitlement.

6. MEDICAL ATTENTION ON TOUR:

An Employee on tour to a place where there is no approved Hospital may arrange for Medical Attention and treatment from any registered medical practitioner or in any hospital at that place and, on production in original of the prescriptions, invoices with receipts for payment and cash memos, may claim reimbursement of expenses on such Medical Attention and treatment. Such reimbursements shall be covered by the Insurance Company in its Medical/Health Insurance Policy.

7. MEDICAL ATTENTION DURING LEAVE:

An Employee on leave or his/her Family visiting a place where there is no approved Hospital may arrange for Medical Attention and treatment from any hospital at that place and, on production in original of the prescriptions, invoices with receipts for payment and cash memos, may claim reimbursement of expenses on such Medical Attention and treatment. Such reimbursements shall be covered by the Insurance Company in its Medical/Health Insurance Policy.

8. REIMBURSEMENT OF MEDICAL EXPENSES IN EMERGENCY CASES/ MEDICAL ATTENTION DURING VISIT/LEAVE:

All medical emergencies shall be managed in Fund's medical cover procedures. It will be built in the insurance cover that such reimbursements could be covered by

the Insurance Company.

- 8.1 Claims for reimbursement of cost of medicines prescribed by an Approved Hospital for treatment during hospitalization but not available with the Approved Hospital, shall be entertained only when accompanied by:
- a) The concerned Doctor's prescription for the required medicines.
 - b) Cash memos evidencing purchase of medicines verified by the claimant and countersigned by General Manager, Support Services Group.
 - c) Discharge Certificate from the concerned Department of the approved Hospital.
- 8.2 In cases of treatment of patients at places other than the place of posting of the Employee, treatment only from well reputed hospitals shall be received.
- 8.3 Insurer shall reimburse the expenses which an employee and or his/her dependents, shall incur against emergency cases or medical attention during visits / leaves for acquiring health services from other than the panel hospitals, clinic, maternity home or other institutions.
- 8.4 All such claims shall be settled within 12 days of their receipt at Insurer's office at Islamabad / Rawalpindi.
- 8.5 Claims of Reimbursement shall be verified by GM (Support Services Group) of NDRMF and shall be lodged with the Insurer on monthly basis.

11. EXCLUSIONS

Fund's medical reimbursement policy does not cover claims directly or indirectly from or consequent upon:

- a. Treatment of injuries resulting from participation in war, invasion, or revolution.
- b. Any increase in expenses incurred for treatment on account of the insured member being admitted to a more expensive room than allowed by his daily room and board sub-limit.
- c. General health check-ups and immunizations.
- d. Congenital defects and deformities (of any nature whatsoever).
- e. Treatment relating to infertility; however, initial laboratory tests prescribed by specialist doctors to verify infertility can be disbursed. Nevertheless, the treatment of temporary (secondary) infertility due to inconsistency of hormones shall be reimbursed upon certification by the consulting doctor,
- f. Costs resulting from self-inflicted injury, suicide, abuse of alcohol, drug addiction, nervous or mental disorder, Sleep disorders, psychotic, mental or nervous disorders and treatment of sexuality-transmitted diseases.

- g. Acquired immune deficiency syndrome (AIDS), AIDS related complex syndrome (ARCS) and all diseases caused by and or related to virus HIV positive,
- h. Cosmetic or plastic surgery unless necessitated by an accidental injury occurred during the employment period,
- i. Any physical or mental condition, which originated prior to the effective date of appointment on regular contract and completion of probation period,
- j. Sports/Recreational injuries and/or complications arising thereof,

Pre-existing diseases of employees as well as their dependents (spouse children and parents) shall be covered.
