**AUCTION NOTICE**

Ministry of Foreign Affairs intends to auction obsolete/unserviceable antennas/booster (five large and two small) installed/erected at the roof top of the Agha Shahi Block of the Ministry on “As it is and where it is basis”.

**Terms and Conditions**

1. The obsolete/unserviceable antennas/booster items can be inspected during office hours (1000 to 1600 hrs) at Ministry of Foreign Affairs, G-5/1, Islamabad.
2. Auction will be held on **23<sup>rd</sup> October, 2023 at 11:30 hours** on “as and where basis” through open bidding at Ministry of Foreign Affairs, G-5/1, Islamabad.
3. Original CNIC is compulsory for all participants. Successful bidder will also deposit photocopy of CNIC for official record.
4. All bidders will deposit Rs.50,000/- as earnest money in shape of demand draft in favor of Ministry of Foreign Affairs before start of auction.
5. Successful bidder will deposit 25% of full payment of auction amount in cash on the spot otherwise bid will be cancelled and earnest money will be fortified.
6. Rest of the auction amount and advance tax (if applicable) will be deposited in government treasury account by successful bidder within five (05) working days positively, otherwise, bid will be cancelled and amount which is already deposited will be fortified.
7. Successful bidder will remove and dismantle above mentioned items within 20 days after the auction date. After 20 days, Rs. 5000/- per day will be charged as penalty.
8. In case of any damage to building during removal of items then repair/maintenance will be done as per original shape by successful bidder, otherwise, items will not be allowed to carry from building premises till repair/maintenance.
9. Earnest Money of unsuccessful bidder will be returned at spot after auction. The refund request will not be entertained until completion of auction.
