 - CNIC of the prospective bidders.
 - The bidder must submit 01 set of bidding documents duly addressed to Executive Engineer B&R Division Chilas and one duplicate copy addressed to Chief Engineer Diamer-Astore Region for transparency.
 - Rates quoted below 10% of the technical sanction shall be considered as unworkable, however,
 - c. The bidder quoting rates below 10% of T/S shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (between T/S & Bid) in shape of CDR/Bank Guarantee from any schedule bank or guarantee bound from any AA rating insurance company duly certified/vetted by the Head Office of the insurance company.
 - d. In case of failure to produce the required deferential amount of the bid by the bidder along with his bid documents, the bid shall be rejected and security of such bidder shall be forfeited
