
**NOTICE INVITING E-BIDDING**

**Terms and Conditions:-**

1. Bid documents and instruction to bidder can be viewed / downloaded from e-tender portal <https://etender.mlc.gov.pk>, or it can be received from the office of CB Sargodha Club Road, Sargodha. Payment of tender/ Bidding fees in favor of CB Sargodha amounting 2,000 PKR is compulsory.
2. The bids can only be submitted in electronic format through e-tender portal from **06-05-2025 at 08:00 AM**. The deadline for submission of bid is **21-05-2025 at 11:00 AM** Bids would be opened on **21-05-2025 at 12:30 Pm**. No manual tender shall be entertained.
3. Rates shall be quoted on the basis of MES Schedule of rates, 2021 (amended from time to time) on percentage basis.
4. The bidder shall submit through courier / contractor representative 02 % bid security of estimated cost duly sealed in envelope in shape of call deposit in (Original) from scheduled Bank on **21-05-2025** before **11:00 AM** as per para (2).
5. E-Bidding without attachment of call deposit / bid bond equal to the earnest money in favor of the undersigned will be rejected.
6. Cantt Board Sargodha reserves the rights to reject any or all tenders as per Rule 33 (1) of PPRA Rules, 2004 by assigning reason thereof.
7. The validity of bid rates shall be up to 180 days as per PPRA / PEC Rules.
8. Eligible firms are required to submit undertaking on judicial stamp paper that his firm is not involved in any kind of litigation against any government department.
