3. Non Refundable tender cost amounting to **Rs.5,000/- (Rupees: Five Thousand Only)**.


The bids in sealed envelope should be dropped in the tender box, in the office of the undersigned on **22-05-2023** up to **02:30 P.M.** The respective bids will be opened on the same day at **03:00 P.M.** in the presence of contractors or their authorized representatives. Other terms and conditions can be seen in the bidding documents.

TERMS & CONDITIONS.

1. Tender documents can be purchased on production of proof of being **Proprietor** of the firm or their authorized representative possessing valid power of attorney.
2. No bidding document will be sold/issued after the closing date.
3. In case of public holiday, the receipt and opening of tenders will be the next working day.
4. No bidding document will be issued through *email, whatsapp* etc.
5. Bids security @ **2% (Two percent)** of bid price, in the form of **Deposit at Call**, (CDR) in the name of Executive Engineer, Central Civil Division No. II Pak PWD Lahore, from any scheduled bank of Pakistan, should be attached along with the sealed bid, otherwise bid will be rejected.
6. The documents of the firm, CNIC, NTN, valid Pakistan Engineering Council License etc. should be available with the intending contractors at the time of purchase of tenders, failing which bidding documents will not be issued.
7. Invitation to bid, is also available at **PPRA Website** (www.ppra.org.pk).

If the bid amount of successful bidder is seriously unbalance in relation to the Detailed Estimate, the bidder shall have to furnish additional Performance Security equal to the difference of Estimated Cost and total bid amount in the shape of Bank instrument issued by any Scheduled Bank of Pakistan as per satisfaction of the Employer besides furnishing detailed price analysis to demonstrate internal consistency of his rates as per Clause IB.28.4 of bidding document.
9. Under clause 33 (1) of Public Procurements Rules 2004, the competent authority reserves the right to reject all bids or proposals, at any time, prior to acceptance.
10. The submission of bids by the contractor implies that he is fully conversant with the site of work, scope of work and all the terms & conditions, laid down in the bidding documents.
