## **Section II. Instructions to Bidders (ITBs)**

	A. Introduction
1. Scope of Application	1.1 The Procuring Agency (PA), as indicated in the <b>Bid Data Sheet (BDS)</b> invite Bids for the provision of Goods as specified in the BDS and Section V Technical Specifications & Schedule of Requirements. The successful Bidde will be expected to supply and install the machine within the specified period and timeline(s) as stated in the BDS.
2. Sources of Funds	2.1 Source of funds is referred in Clause-2 of Invitation to Bids.
3. Eligible Bidders	3.1 A Bidder may be natural person, company or firm or public or semi-publ agency of Pakistan or of any foreign country, or any combination of them wir a formal existing agreement (on Judicial Papers) in the form of a joint venture consortium, or association. In the case of a joint venture, consortium, association, all members shall be jointly and severally liable for the execution the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member and on behalf of any and all the members of the joint venture, consortium, association during the Bidding process, and in case of award of contract, during the execution of contract.
	3.2 The appointment of Lead Member in the joint venture, consortium, association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency.
	3.3 Verifiable copy of the agreement that forms a joint venture, consortium association shall be required to be submitted as part of the Bid.
	3.4 Any bid submitted by the joint venture, consortium or association shall indica the part of proposed contract to be performed by each party and each party sha be evaluated (or post qualified if required) with respect to its contribution onl and the responsibilities of each party shall not be substantially altered withor prior written approval of the Procuring Agency and in line with any instruction issued by the Authority.
	3.5 The invitation for Bids is open to all prospective supplier, manufacturers authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national incorporating agency or statutory body established for that particular trade or business.
	3.6 Foreign Bidders must be locally registered with the appropriate nation incorporating body or the statutory body, before participating in the national/international competitive tendering with the exception of succeptor procurements made by the foreign missions of Pakistan. For such purpose the bidder must have to initiate the registration process before the bid submission and the necessary evidence shall be submitted to the procuring agency alor with their bid, however, the final award will be subject to the comple
	registration process.  3.7 A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidders may be considered to have a conflict of interest with one or more parties in this Bidding process, if they:  a. are associated or have been associated in the past, directly or indirect with a firm or any of its affiliates which have been engaged by the Procuring Agency to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of goods and related services to be procured under the Invitation for Bids.  b. have controlling shareholders in common; or  c. receive or have received any direct or indirect subsidy from any of them or

### Before the deadline for submission of Bids, the Procuring Agency for any Amendment of Bidding reason, whether at its own initiative or in response to a clarification requested by **Documents** a prospective Bidder or pre-bid meeting may modify the Bidding Documents by issuing addenda. 9.2 Any addendum issued including the notice of any extension of the deadline shall be part of the Bidding Documents pursuant to ITB 7.1 and shall be communicated in writing or in any identified electronic form that provide record of the content of communication to all the bidders who have obtained the Bidding Documents from the Procuring Agency. - 35.2 The Procuring Agency may adopt the Quality & Cost Based Selection Technique due to the following two reasons:
  - i. Where the Procuring Agency knows about the main features, usage and output of the products; however not clear about the complete features, technical specifications and functionalities of the goods to be procured and requires the bidders to submit their proposals defining those features, specifications and functionalities; or
  - ii. Where the Procuring Agency, in addition to the mandatory requirements and mandatory technical specifications, requires parameters **specified in Evaluation Criteria** to be evaluated while determining the quality of the goods:

In such cases, the Procuring Agency may allocate certain weightage to these factors as a part of Evaluation Criteria, and may determine the ranking of the bidders on the basis of combined evaluation in accordance with provisions of Rule 2(1)(h) of PPR-2004.

## 36. Post qualification of Bidder and/or Abnormally Low Financial Proposal

- 36.1 After determining the Most Advantageous Bid, if neither the pre-qualification was undertaken separately nor any qualification parameters were undertaken as part of determining the Most Advantageous Bid, the Procuring Agency shall carry out the post-qualification of the Bidder using only the requirements specified in the BDS.
  - In case of International Tendering, the parameters for incorporation or licensing within Pakistan may be fulfilled as part of post qualification.
- 36.2 Where the Bid price is considered to be abnormally low, the Procuring Agency shall perform price analysis either during determination of Most Advantageous Bid or as a part of the post-qualification process. The following process shall apply:
  - (a) The Procuring Agency may reject a Bid if the Procuring Agency has determined that the price in combination with other constituent elements of the Bid is abnormally low in relation to the subject matter of the procurement (i.e. scope of the procurement or ancillary services) and raises concerns as to the capability and capacity of the respective Bidder to perform that contract
  - (b) Before rejecting an abnormally low Bid the Procuring Agency shall request the Bidder an explanation of the Bid or of those parts which it considers contribute to the Bid being abnormally low; take account of the evidence provided in response to a request in writing; and subsequently verify the Bid or parts of the Bid being abnormally low;
  - (c) The decision of the Procuring Agency to reject a Bid and reasons for the decision shall be recorded in the procurement proceedings and promptly communicated to the Bidder concerned;
  - (d) The Procuring Agency shall not incur any liability solely by rejecting abnormally Bid; and
  - (e) An abnormally low Bid means, in the light of the Procuring Agency's estimate and of all the Bids submitted, the Bid appears to be abnormally low by not providing a margin for normal levels of profit.

### Guidance for Procuring Agency:

In order to identify the Abnormally Low Bid (ALB) following approaches can be considered to minimize the scope of subjectivity:

- (i) Comparing the bid price with the cost estimate;
- (ii) Comparing the bid price with the bids offered by other bidders submitting substantially responsive bids; and
- (iii) Comparing the bid price with prices paid in similar contracts in the recent past either government- or development partner-funded.

The rates and prices entered in the priced Bill of Quantities shall, except insofar as it is otherwise provided under the Contract include all costs of Contractor's labour, supervision, materials, execution, insurance, profit, taxes and duties, together with all general risks, liabilities and obligations set out or implied in the Contract. Furthermore, all duties, taxes and other levies payable by the Contractor under the Contract, or for any other cause, as on the date 28 days prior to deadline for submission of Bids, shall be included in the rates and prices and the total Bid Price submitted by the Bidder.
- 4. A rate or price shall be entered against each item in the priced Bill of Quantities, whether quantities are stated or not. The cost of items against which the Contractor will have failed to enter a rate or price shall be deemed to be covered by other rates and prices entered in the Bill of Quantities.
- 5. The whole cost of complying with the provisions of the Contract shall be included in the items provided in the priced Bill of Quantities, and where no items are provided, the cost shall be deemed to be distributed among the rates and prices entered for the related items of the Works.
- 6. General directions and description of work and materials are not necessarily repeated nor summarized in the Bill of Quantities. References to the relevant sections of the Bidding Documents shall be made before entering prices against each item in the priced Bill of Quantities.
- 7. Where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern, and the line total will be corrected accordingly.
- 8. Each cutting should be signed by the authorized person.
- 9. The brand names have been provided in order to establish a standard of performance and reliability. However, it does not indicate a preference for a particular brand. The bidder may propose other brands which can be accepted subject to necessary tests to establish equivalency.
- 10. Where packaging size of a sachet/packet/can/pack etc. is included in the description of item of BOQ, this packaging size is only for reference and does not indicate preference for any specific brand. The bidder may offer another packaging size with a margin or tolerance of no more than 15% of the specified size. However, the total quantity to be supplied must be equal to the cumulative quantity required in the BOQ item.
