



INVITATION FOR BIDS

- i. Chief Commissioner's Office, ICT "Employer" invites bids from Contractors/Firms/JV registered with Private Power and Infrastructure Board (the "PPIB") under AEDB (Certification) Regulations, 2021 in the relevant category and Pakistan Engineering Council (PEC) Registration in Category C-6 and above with relevant codes e.g. (EE11) for the "Design, Supply, Installation, Testing & Commissioning of net-metering based Solar PV Systems of 123 KW" at its premises.
- ii. Single Stage – Two Envelope bidding process will be adopted. Bidding Documents containing detailed terms and conditions are available at Chief Commissioner's Office, ICT's website i.e., [<https://ictadministration.gov.pk/>]. The Bidding Documents can be downloaded from Chief Commissioner's Office, ICT website and from Federal Public Procurement Regulatory Authority (PPRA) website.
- iii. All the applicants have to fulfill the mandatory eligibility requirements given in the bidding data under instructions to Bidders. If any bidder/company does not fulfill any of the above requirements for bid evaluation criteria (IB-12) shall be considered as disqualified and no further evaluation of such bidder/company/firm will be done.
- iv. All duties, taxes, insurance and other levies payable by the Contractor/Firms under the Contract, or for any other cause shall be included in the rates and prices and the total Bid Price submitted by a Contractors/Firms.
- v. Government shall deduct taxes at the rate prescribed under tax laws of Pakistan, from all payments for service rendered and work done by a Contractor/Firm sign a contract.
- vi. All bids accompanied by a Bid Security amounting to [Rs. 14,000/-] per KW (123 KW) in shape of pay-order/demand Draft issued in favor of Accounts Officer, Chief Commissioner's Office, ICT, must reach at the office of Chief Commissioner's Office, ICT, Mauve Area, G-11/4 Islamabad on or before, June 11, 2025, at 11:00 AM. The pay-order/demand Draft must be attached with the Technical Bid instead of Financial Bid. No cheque would be accepted.
