ESTABLISHMENT, OPERATION, MANAGEMENT & MAINTENANCE OF HAZARA MINI SERVICE AREA ALONG WITH FILLING STATIONS AT KM-26 (NORTH BOUND) ON HASSANABDAL-HAVELIAN EXPRESSWAY (E-35) ON ADVANCE NET GUARANTEED REVENUE BASIS

Hassanabdal – Havelian expressway (E-35) is a six (06) lane 59.5 Kms long access controlled expressway which connects the Hazara Division and Gilgit Baltistan (Northern Areas of Pakistan) with KPK, Islamabad and Punjab.

2. NHA envisages to engage Oil Marketing Company(ies) (OMCs) duly registered with SECP, having valid license from OGRA or authorised retailers/dealers of any OMC by making JV with C-3 or above category firm for subject assignment on Advanced Quarterly Net Guaranteed Revenue basis for a period of seventeen (17) years.

3. **The successful bidder shall establish, operate, manage & maintain the mini service area facility as mentioned in Article – II, Scope of Concession at Hazara mini service area on Hassanabdal-Havelian expressway (E-35) at its own cost and expense.**

The request for proposal (RFP) documents (comprising detailed terms & conditions, scope and requisite forms etc.) can be obtained from the office of Director (FR/HB) NHA-HQ, Islamabad during office hours after **Thursday, 05th August 2021** by depositing of Rs.2000/- (non-refundable) in form of pay order in favour of National Highway Authority, Road Maintenance Account.
