OPERATION, MANAGEMENT & MAINTENANCE OF ALREADY ESTABLISHED SERVICE AREA FACILITY AND CONSTRUCTION, OPERATION, MANAGEMENT & MAINTENANCE OF FILLING STATIONS ALONGWITH ALLIED FACILITIES AT KUZA BANDA SERVICE AREA, KM-161 (NORTH BOUND) ON MANSEHRA-THAKOT SECTION OF CPEC HAVELIAN-THAKOT ON ADVANCE NET GUARANTEED REVENUE BASIS

Havelian-Mansehra road section connects the central & southern part of country with northern Pakistan and is the main route of China – Pakistan Economic Corridor (CPEC).

2. NHA envisages to engage Oil Marketing Company(ies) (OMCs) duly registered with SECP, having valid license from OGRA or authorised retailers/dealers of any OMC by making JV with C-3 or above category firm, for subject assignment on Advanced Quarterly Net Guaranteed Revenue basis for a period of twelve (12) years.

3. **The successful bidder shall have to Operate, Manage & Maintain the already established Service Area facility (i.e. Kuza Banda mini service area) and construct the Filling Station along with Allied Facilities (as mentioned at Article – II, Scope of Concession) at Kuza Banda mini service area at its own cost and expense.**

The request for proposal (RFP) documents (comprising detailed terms & conditions, scope and requisite Forms etc.) can be obtained from the office of Director (FR/HB) NHA-HQ, Islamabad during office hours after **Thursday, 05th August 2021** by depositing of Rs.2000/- (non-refundable) in form of pay order in favour of National Highway Authority Road Maintenance Account.
