
### **TERMS AND CONDITIONS**

03. Repair Work should be completed within the stipulated period as mentioned in our Work order when placed on the lowest bidder(s).
04. CPGCL may reject all bids or proposals at any time prior to the acceptance of a bid or proposal in the light of PPRA rule No. 33 (1)".
05. Department reserves the right to increase/decrease the quantity.
06. The Bidder must indicate the validity period of its offer, which should not be less than 60 days from the date of opening of quotation.
07. Rates offered shall be considered as firm and final. Rate should be mentioned in words as well as in figures.
