CDR of successful bidder will be released after the completion of supply however CDR of remaining bidders will be released after the finalization of bids.
3. Bidding documents shall be issued to the Govt. contractor in person on production of original CNIC, PEC registration certificate 2020-21 on request of written application form.
4. Conditional or incomplete bids shall be liable to rejection.
5. Rates quoted by contractor below 10% of the T/S cost will submit 50% of difference amount in shape of TDR in the name of Project Director along with bid security. In case of non-production, the bid will not be considered.
6. No bid documents will be issued on the date of opening of bid.
7. Brochures depicting the complete pictures and features of the items must be attached. Successful bidder will be bound to deliver and fix the supplies/items to the Central Jail Minawar Gilgit.
8. The procuring agency may reject all bids or proposals at any time prior to the acceptance of bid under the provision of Rule 33 of PPRA Rule 2004.
