The contractor who are entitled with MES in category '**A, B, C, D, E**' are required to submit their applications for issuance of tender documents along with their complete credential as shown at serial-5 up to **16 May 2025**. The applications shall be scrutinized and the tender documents will only be issued to the firm who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tender will be issued to the scrutinized contractors on **23 May 2025**. The tenders must be received to the accepting officer by 1130 hours on **23 May 2025** and will be opened on the same date at 1200 hours.

3. Firms/Contractors, not born on approved list of MES will furnish with their application proof of their being on the appropriate list of the Department concerned, a statement of financial standing with necessary bank certificate, details of tools and plants and detail of previous experience giving detail and type of work, executed in the last two years and in hand on the Proforma appended below duly attested by Class-I Gazetted Officer.

4. Firms/Contractors, not born of MES approved list of contractors or those suspended from the approved list of MES due to non depositing enhanced amount will deposit 2% of above mentioned cost (separately) as earnest money in the form of FDR, Deposit at Call etc duly pledged in the name of GE Maint / Proj NDU Islamabad. This amount is refundable, if the contractors are not prequalified / they do not secure the contract.

5. Applicants not providing the information on the following Proforma and/or earnest money will not be considered for issue of tender.
