**Invitation of Bids for Hiring of Consultants for GIS data Mapping Through Enterprise Web  
base Application Based on Technological Innovation for Infrastructure of HESCO,  
Hyderabad**

1. Hyderabad Electric Supply Company (HESCO), Hyderabad endeavoring to provide uninterrupted electric supply services to more than 1.23 Million valued consumers of 13 districts of Sindh Province.
2. HESCO is performing the system studies for Grid & Transmission Network through PSS/E software for the purpose of Transmission System Expansion Planning. Besides this, HESCO is also using Arc GIS and SynerGEE Electric Software for GIS mapping of distribution network and analysis for the purpose of Rehabilitation / Planning of 11kV feeders.
3. HESCO intends to implement the web based automated system & 100% survey of Grid & Transmission network as well as 11kV feeders, LT Lines, distribution transformers, PVC & energy meters up-to consumer premises and its GIS mapping on turn-key basis. Those eligible firms who have executed similar assignments to submit sealed Request for Proposal (RFP) along with the following information;
  - a. Firm must be registered with PEC.
  - b. Minimum 03(three) years relevant experience in field of GIS survey for power sector.
  - c. Number and detail of similar projects, scope of works, contract value & client profile/name and assignments undertaken.
  - d. Financial position of the firm as per Qualification and Evaluation Criteria.
  - e. Organizational Chart including professional staff strength for relevant assignment.
  - f. Valid Firm's Registration Certificate from Pakistan Engineering Council.
  - g. Performance certificate from the clients served.
  - h. Registration copy of NTN, GST Income Tax (active tax payer) and Sindh Revenue Board etc.
  - i. Other terms & conditions are mentioned in Bidding Documents.
4. RFP document will be issued to the eligible and interested bidders after submission of documents as mentioned at serial -3 (f&h) above.
5. The RFP procedure will be based upon "Single Stage Two Envelop"(QCBS) method as prescribed under PPRA rules containing separate sealed covers "Technical Proposal"& "Financial Proposal"and both envelopes sealed in common outer envelope.
6. RFP shall be accompanied with Bid Security amounting to Rs.5.0 Million in shape of pay order / bank draft in favor of CEO, HESCO, valid for 28 days beyond bid validity. The bid shall be valid for 180 days. Original bid security must be in the Technical Bid Envelop otherwise bid shall be rejected.
7. The firm(s) will be selected in accordance with the procedure set out in the PPRA Rules(amended to date). Interested bidders fulfilling the above requirements can obtain Tender Documents (RFP) from the office of undersigned at a price of Rs.10, 000/-(Rupees Ten Thousand Only)each(non-refundable).
8. **Pre-bid meeting will be held on 20<sup>th</sup> March, 2024 at 1100Hrs.** For entry in pre-bid meeting, showing of tender document fees slip is mandatory. However, written queries and their response will be considered part of Bidding documents/RFP.
9. RFP is required to be submitted to the office of Chief Engineer (P&E) HESCO, Hyderabad on or before **18<sup>th</sup> April, 2024 at 1100 Hrs.** The Technical proposal shall be opened on same day at 1130 Hrs. Financial proposal will be retained unopened in the same office. Financial proposal shall be opened only of those bidders who successfully meet minimum passing technical score. Financial proposal of un-qualified Firms shall be returned un-opened.
10. Bids received after the Date and Time specified above shall not be accepted.
11. Electronic bid shall not be accepted.
12. Conditional bid or bids without security shall not be accepted.
13. HESCO reserves the right to accept or reject all proposals at any time according to PPRA Rules 33(1).
