2. Pakistan Engineering Council Registration renewed for year 2022-23 with at least **Category C-6** having Specialization Code of **CE-10**.
3. The bidder must have demonstrated at least three year experience in the field of construction as per registration categories of PEC.
4. A Bidder may be in person, private entity, or government-owned enterprise or any combination who is active tax payer.
5. The bidder/JV shall have furnished income tax returns for last three years to FBR.
6. Bidder will provide the fresh bank balance of firm upto 50% of estimate cost.
7. The bidder will show the two work orders of building work amounting to RS.08.00 Million each within last two year of NTDC, WAPDA, DISCOS and having experiences for construction of double storey building within last three years.
