MAJOR TERMS & CONDITIONS ARE AS UNDER: -

1. The tenderer shall submit Rs. 150,000/- bid security in the shape of call deposit and attach its valid soft copy alongwith bid challan with the quoted bid before closing date & time.
2. The tenderer is bound to submit verified and genuine documents as well as call deposit, if documents are found altered / fake / bogus, the Cantonment Board would be at liberty to initiate criminal proceedings by lodging FIR on the basis of forgery / fraud against the tenderer and black listing of the firm.
3. The tenders can be submitted from the date of publication in newspaper and uploading on PPRA, the deadline for submission of tender is **25/04/2022** at **1000hrs**. The tenders would be opened in the office of Cantt Board Murree Hills on the same day at **1100hrs**.
4. Single stage one envelope method of procurement / work / tendering will be adopted as envisaged in PPRA rules.
5. Any information regarding the tender can be obtained from the office of the Cantonment Board Murree Hills during office hours.
6. The validity of Tender / Quotation rates shall be minimum upto **180** days as per PPRA / PEC Rules.
7. The Cantonment Board reserves the right of demanding the analysis of the quoted rates from the concerned tenderer to check their reasonability / workability ✓

8. In case if the lowest tendered rate is less than reasonable rates, the lowest tenderer shall have to deposit standing security (refundable after successful completion of the work) @**10%** of estimated cost in the shape of Call Deposit Receipt (CDR) within **05** days. In case of failure the already deposited Rs. 150,000/- in shape of call deposite shall be forfeited and the tender shall be offered to **2nd** lowest participant as per rules.
9. The quantum of work may increase / decrease as per PPRA Rules and lowest tenderer shall be bound to execute the work on similar rates / terms & conditions.
10. Rates should be quoted on Lumpsum basis.
11. Quoted rates must be inclusive of all applicable taxes.
12. The issuance of work order shall be subject to approval of the Cantt Board.
13. All dues / taxes will be deducted as per government rules.
14. The bidder shall be responsible to replace any material on its own account that is found faulty or of inferior quality to meet the requirement.
15. Period of warranty and maintenance with labour and material cost shall be one year.
16. Before execution of work, the sample of proposal will be examined and finalized by the Board.
17. Successful tenderer will be bound to deposit mandatory dues as already resolved by the Board and shall have to execute an agreement (at their own cost) on non-judicial stamp paper of appropriate value for faithful execution of the contract.
18. The Cantonment Board reserves the right to reject all tenders as per PPRA's Rules No. **33(1)** due to any reason thereof.
