1. **Submission Deadline:** The bid shall be **(submitted on EPADS by mention date)** and delivered in person at office of Provincial Election Commissioner, Sindh, Karachi, which should reach according to schedule for tender Tenders will be opened on the same date at 11:30 AM in the presence of the Tender Committee and bidders. E-mailed or faxed bids will not be accepted.
2. **Tender Documents:** The detailed of each tender documents can be obtained upon a written request from the **Provincial Election Commissioner (S) Karachi office at Pakistan Secretariat Block 44-A Shahrah-e-Iraq Saddar Karachi**, against a non-refundable fee of **Rs. 2,000/- (Two Thousand Rupees only)**. The last date for obtaining tender documents is **before tender opening time & date (as mentioned above), till 11:00 AM**.
3. **Rate Quotation:** Bidders must quote rates for each item separately. No firm will be allowed to modify the rates after the opening of e-bids.
4. **Compliance with PPRA Rules:** Bidders must not propose their own terms and conditions that conflict with the tender documents or PPRA Rules. In case of any dispute, PPRA Rules and tender document conditions shall prevail.
5. **Bidding Procedure:** Tendering will follow the **Single Stage-Two Envelopes Method**, where a single outer envelope should contain two separate envelopes labeled **"FINANCIAL PROPOSAL"** and **"TECHNICAL PROPOSAL"** in bold, legible letters to avoid confusion.
6. **Office & Support Services:** The company should have support/service offices in Sindh or other major cities in Province.
7. **Experience Requirement:** The company must have a minimum of five (05) years' experience in the relevant field.
8. **OEM Partner Certification:** The bidder must provide an authorized OEM Partner/Dealer Certificate from the principal manufacturer (Gold Partner preferred) along with an ISO Certification.

9. **Non-Blacklisting Certificate:** Bidders must submit a certificate confirming that their company has never been blacklisted or declared a defaulter by any Federal or Provincial Government Department in Pakistan.
10. **Price Quotation:** Prices should be quoted in Pakistani Rupees (PKR), both in words and figures.
11. **Bid Validity:** The quoted prices must be firm, final, and clearly written without ambiguity. Bids will remain valid for six (06) months from the submission deadline.
12. **Inclusive Pricing:** The quoted price must be all-inclusive, covering government taxes (including GST, if applicable), duties, delivery, and installation charges.
13. **Bill of Quantities (BOQ):** Rates must be provided against each item in the BOQ (Bill of Quantities).
14. **Bid Security:** Each bidder must submit a Bid Security/Earnest Money equivalent to 5% of the total bid value for each item separately. This must be in the form of a Bank Draft or Pay Order issued by a Scheduled Bank of Pakistan, payable to the DDO, Office of the Provincial Election Commissioner, Sindh, Karachi. This security must be submitted physically to the Provincial Election Commissioner, Sindh Karachi Officer, before the deadline.
15. **Delivery Timeline:** The successful bidder must complete delivery and supply of items within thirty (30) days after signing the contract.
16. **Quantity Adjustment:** The Procuring Agency reserves the right to increase or decrease the number of items required at any stage based on actual requirements.
17. **Tender Rejection Rights:** The Procuring Agency/Competent Authority reserves the right to reject any or all tenders in accordance with Rule-33(1) of PPRA Rules-2004.
