Tenders will be issued to the scrutinized contractors on 20 May 2025. The Tenders must be received in the accepting officer by 1130 Hours on 26 May 2025 and will be opened on the same date at 1200 Hours or date shown on tender documents.

Note: Contractor shall provide certificate that they are not involved in any type of litigation with Govt Department in the Court of Law and that no special report of Directorate of inspection and Evaluations (E-in-C's Branch, GHQ) is outstanding against them.

- 4. All Contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.
- 5. Contractor born on approved list of MES in Category 'A', 'B', 'C' & 'D' also having experience of this type should only apply.
- 6. Copies of the conditions of contract, schedules and all other documents connected with the work (signed for the purpose of identification) shall be open for inspection of the contractors, at the office CMES (DP) PAC Kamra during office hours. Tenders shall be deemed to have full knowledge of all such information whether they have inspected these or otherwise.
- Contractor who desire may be present at the time of opening of tenders.
