**TENDER NOTICE THROUGH NEWSPAPER AND PPRA**



PWD Bathkela from the date of publication till **21-11-2022** during office timings. **Tender fee as mentioned below (Non-refundable) in the form of Cash/Pay order/Demand Draft along with 04% Bid Security in the shape of CDR from scheduled bank of Pakistan to be attached with the Application for issuance of tender documents in favour of "Executive Engineer Project Civil Division Pak. PWD Bathkela" CDR shall be deposited in relevant divisional PLA account and released via cheque by the undersigned.** Tenders will be issued by applying on original letter-pad by owners of firms or their authorized representatives having registered power of attorney of the firm (on affidavit and duly registered with registrar of firms). No proxy will be allowed to participate. No cheque or pay order on this account will be accepted on / before the date of opening of tenders. The tender documents must reach in the office of the undersigned by **22-11-2022 at 11:00A.M** and shall be opened on same day at **11:30 A.M** in the presence of contractors or their authorized representatives and/or bid evaluation committee. Tenders received by mail, courier and fax or telegraphically shall not be entertained. The firms providing unsubstantiated, incomplete, incorrect or false information are liable to disqualification and legal action. **The Pak. PWD reserves the right to reject any or all the tenders under PPRA Rule 33(1) of 2004. Additional performance guarantee, if required, will be governed through Clause IB-28.4 of bidding documents. Non-compliance of instructions to bidder in the Tender Documents will lead to disqualification/non-responsiveness of the bid/firm. IMPORTANT: If the tenders are not opened as per schedule mentioned above, 2nd schedule date will be on 28-11-2022 and tenders will be opened accordingly on 29-11-2022.**

• **REQUIREMENT FOR ISSUANCE OF TENDER DOCUMENTS:**

- Attested copy of NIC of owner/auth. Representative and Valid/Renewed PEC Registration Certificate in relevant category having specialized codes CE-01, CE-09 and CE-10.
- Firms/Contractors must be on active tax payers list (ATL) of FBR.
- Valid registration with Tax Authorities i.e. NTN.
- No litigation certificate on Judicial/Stamped paper.
- The applicant firm should have completed at-least 03 No. works of similar nature in last 03 years equal to/or more than NIT/AA amount and documentary proof to this effect duly verified by the issuing office will be attached with the application.
- The applicant firm will submit documentary evidence of 03 years average annual construction turnover equal to or more than the NIT/AA amount from a QCR rated audit firm.
- List of relevant equipment/machinery and list of personnel including PEC registered Civil Engr., DAE Engrs, Supervisory staff etc.
- All Other terms and conditions are contained in the bidding documents.
