- v. Consultancy Firm have to submit an undertaking on a stamp paper that the firm has never been black listed by any government / non-government department / organization.

- i. In order to qualify for the next stage, the Consulting Firms must meet the above stated eligibility / Evaluation criteria. Shortlisted firms qualifying as per above stated eligibility criteria will be contacted for submission of Technical and Financial Proposals pursuant to Regulation-3 (C) Method of Selection of Consultants "Procurement of Consultancy Services Regulation 2010" of PPRA "Least Cost Method" will be adopted for the selection of Service Provider.
