

2. Contractors/Suppliers have complete set up (own shop/workshop), technical experts/staff, vast and past experience with documentary evidence).
3. The Contractor/Suppliers must be sole proprietor having his own complete setup (shop or workshop) containing adequate supplies in Gilgit-Baltistan and he will be bound to supply demanded items at the SPU HQ CPO Gilgit.
4. The bid should be accompanied with a call deposit (with technical bid) as mentioned above.
5. The bid Security / call deposit in shape of Bank Draft/Pay Order by a scheduled bank in the name of DIG HQ/PD SPU GB Gilgit may be attached with the bidding/tender documents. Tender without call deposit from a scheduled bank, will not be accepted.
