Interested bidders are required to submit, alongwith the Bid Form, copy of CNIC and a Pay Order / Demand Draft in original amounting to Rs.5,000/- as earnest money (refundable) in favor of Additional Director (Admn), NAB Balochistan on or before 1030 hours on 20th March 2023 enabling them to participate in auction.

Successful bidder shall have to deposit 25% of the offer in cash on the spot and rest of the bid price i.e. 75% shall be deposited & all items will be removed from our premises within 05 working days after accepting the offer, otherwise department will not be responsible for any loss thereof, and 25 % payment will be forfeited.
