The Planning & Development Department (P&DD), Government of Gilgit-Baltistan invites sealed tenders from firms/ companies registered with SECP for "<u>Supply and Installation of Equipment</u> <u>for Establishment of Data Center"</u> at Planning & Development Department Gilgit-Baltistan."

- 1. Proposals will be considered only from companies/firms who have verifiable experience in supply and installation of equipment for the establishment of Data centers.
- 2. The Single Stage-two envelope procedure, as outlined in Section 39(b) of the GB PPRA Rules 2022 has been adopted i.e., the bid shall be a single package consisting of two separate envelopes, containing separately the **Financial & Technical Proposals.**
- 3. The technical & financial proposals of the bidder shall be evaluated using Quality and Cost-Based Selection (QCBS), with 80% weightage given to technical Proposal & 20% to financial Proposal.
- 4. The minimum score for qualifications in technical Proposals is 70%. The Financial Proposal for technically qualified firms will be opened in the presence of authorized representatives.
- The participating firm shall deposit PKR 1,000,000.00 Call Deposit (CDR) only (reflecting the name of the participating firm) from any scheduled bank in favor of <u>Deputy Chief SRC, Planning</u> <u>& Development Department GB</u>, attached to the Technical proposal.
- 6. The bidder must have completed at least one similar nature of project "supply & Installation of equipment for data center" during last two years and local presence in GB for support services.
- 7. Joint venture is not allowed.
- 8. Authorization from the Original Equipment Manufacturer (OEM) is required for distributors or dealers. Alternatively, authorization from the main distributor/dealer in Pakistan is also acceptable.
- 9. Only brand-new items are required with warranties shall be acceptable. Refurbished/old items will not be accepted.
- The tender documents including a detailed Request for Proposal can be obtained from the undersigned during office hours on payment/treasury reciept of non-refundable amount of Rs. 10,000/- (Ten Thousand only) through Treasury Challan before the closing date and time.
