With reference to the advertisement regarding tender notice published for the work: **Uplifting/renovation of Custom House at G-9/1, Islamabad** on PPRA website with tender no. TS561886E and in the newspaper "The News" and "Jang Pakistan" dated 03-05-2024, and EPADs dated 02-05-2025, with opening date 19-05-2025 and closing time of 11:00 a.m., following amendments have been made in the estimate, closing date, mandatory condition of PEC category and Bid Security amount (only), due to the administrative issues, keeping all other contents same as before :-

- 1) The Estimated Amount of Rs. 44,437, 567/- has been curtailed to 24,912,813/-, detailed estimate has been uploaded on EPADs.
- 2) In the mandatory requirement, the PEC category has been changed from "**C-5 and above**" to "**C-6 and above**".
- 3) The Amount of Bid Security has been reduced from **Rs.15, 00,000/- (Rs. 1.5M)** to **Rs.10, 00,000/- (Rs. 1.0 M)**
- 4) Closing date has been extended from **19-05-2025** to **23-05-2025** (closing time 11:00 a.m. and opening time as 11:30 a.m.)

Pakistan Customs is a part of FBR at their collectorate office at Custom House Building at G-9/1, Islamabad invites sealed bids on Single Stage Single Envelope bidding procedure for the renovation and uplifting works at Custom House, Building at G-9/1 Islamabad, on percentage basis (above or below) on Pak PWD Schedule of Rates 2022, from the Contractors, validly registered with Income Tax and Sales Tax Departments and who are on Active Taxpayers List of the Federal Board of Revenue and registered with Pakistan Engineering Council in the relevant category of C-5 and above with specialized code of CE(9,10), EE-11 and ME-01.

2. e-bidding documents as per regulations, containing detailed terms and conditions, specifications and requirements etc. are available for the registered bidders on EPADS at (www.eprocure.gov.pk)

3. All the prospective bidders must upload the legible scanned copies of the documents of mandatory requirements given in the bidding documents, on the EPADS only.

4. The electronic bids, must be submitted by using EPADS on or before (19th May, 2025 and 11:00 a: m). Manual bids, shall not be accepted. Electronic Bids will be opened on the same day at 11:30 a: m.

4. The Original bid security amounting to Rs. 1,500,000/- in the shape of CDR/pay order/ Banker's Cheque issued in the favour of Custom Collectorate, Custom House, Islamabad must reach the office of undersigned, anytime in the office hours before the closing day and time.

5. The time period for the performance of contract is 30 days from the issuance of letter of commencement.
