The tender documents will be issued on production of copies of Authority letters from the firms in the name of employee & income tax registration certificate.

Bids should be submitted in sealed envelopes, delivered at the **O/o Director (C&P), Tarbela Dam Project** on or before **1100 hours** on **27-05-2024** and must be accompanied by a Bid Security of **Rs. 105,000/-** in the form of unconditional Bank Guarantee (on prescribed form of bid security in the bidding document) or in the form of **CDR in favour of GM & PD, TDP**.

Bids will be opened on the same day at 1130 hours in the presence of the bidders or their authorized representatives who choose to attend at the **O/o Director (C&P), Tarbela Dam Project**.

This procurement will be carried out as per PPRA rules, 2004 (single stage-one envelope) as amended time to time.

The Employer reserves the rights to accept or reject any or all bids or proposals at any time prior to acceptance of a bid or proposal.

Note: The Bidder must meet with the following Qualification Criteria:-

- Specific Experience= One or more similar nature assignment, substantially completed with contract price upto 2 Million or more during the last four (04) years. Also provide completion/ substantial certificate from the employer.
- Blacklisted contractor/firms/suppliers/manufacturers are forbidden to bid and on the basis of available information with Wapda will not be considered.
