Six (6) firms have participated. Two (2) of them i.e M/s Hiranis Pharmaceutical (Pvt) Ltd and M/s Otsuka Pakistan Ltd. are the Manufacturers where else the other four (4) firms are Authorized Distributors.

The Meeting of Prequalification Committee was held on 14-12-2024 and following firms were found **“Responsive”** on the basis of Knock Down Criteria as per Prequalification Bidding Documents.



The M/s Shaheen Chemist was not able to provide and prove its documentation regarding being a licensed distributor of specified location. The submitted documents / forms / license are either of retail setup or medical store and there was no license of distribution issued to the Proprietor, Muhammad Qadir.


Hence, on the basis of findings of Prequalification Committee, five (5) firms were found "Responsive" and one (1) firm was found "Non-Responsive".








