

1. The During the visit of the High-ups at East & west Wharves of Port Area, it was observed that, the Water Sabeels in the said Port area are in deteriorated condition and the same needs to be renovated on urgent basis.

Accordingly, in compliance the AXEN (W/S) carried out a survey of the subject sites and prepared an Estimate amounting to Rs.943,359.95 (inclusive of 15% SRB Tax) in accordance with the requirement of the work, placed at S.No.01 to attend the work through outsourcing, as the same is beyond the limits of in house arrangements.

2. According to Rule-36(a) of PPRA tenders for the work were invited through KPT / PPRA & MoMA Website 21-11-2024 and received on 09-12-2024.
