NAME OF WORK: RAISING OF BOUNDARY WALL ADJACENT TO KDLB OFFICE AT KPT HEAD OFFICE.

INTRODUCTION:

1. The Boundary Wall of KPT Head Office protects it from trespassers, comprises length of 3500 R/Mtr. (approx.). Certain pockets especially the wall adjacent o KDLB building require raise in height so as to prevent it from trespassers which is a security concern. Accordingly, AXEN (MIY) has prepared an Estimate amounting to Rs.936,564.34 (including Taxes and Contingencies) placed at S.No.1, for attending the work, as the work is beyond the capacity of KPT In-house arrangements.
2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 27-08-2024.

RECOMMENDATIONS

The Single Evaluated Bid amounting to Rs.998,783.62 (Rupees: Nine Hundred Ninety Eight Thousand Seven Hundred Eighty Three & Sixty Two Paisa Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. Global Construction & Engineering which is 06.64% above the corresponding estimated cost of Rs.936,564.34 based on market rates is considered reasonable. Keeping in view of their past performance as mentioned in Para-2 (m) M/s. Global Construction & Engineering is considered capable for carrying out the work viz. "RAISING OF BOUNDARY WALL ADJACENT TO KDLB OFFICE AT KPT HEAD OFFICE".

The Committee therefore, recommends the acceptance of the Single Evaluated Bid amounting to Rs.998,783.62 (Rupees: Nine Hundred Ninety Eight Thousand Seven Hundred Eighty Three & Sixty Two Paisa Only) received from M/s. Global Construction & Engineering is considered reasonable for the work viz. "RAISING OF BOUNDARY WALL ADJACENT TO KDLB OFFICE AT KPT HEAD OFFICE".
