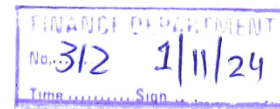

INTRODUCTION:

1. Several Aluminum installations has been fixed in KPT Hospital Keamari Area. Due to wear & tear, quite and often different complaints are being received regarding repairing of aluminum installation which need to attend on time to avoid any inconvenience to staff and as well patients admitted at hospital. Since there exit no such in-house facility / vacancy to attend the complaints in time, hence there is no option left to attend the same through Running Contract.
2. Administrator Officer, KPT Hospital have also requested and letter placed at S.No.1 to attend the subject work. Accordingly, AXEN (KV) has prepared an estimate for Running Contract of 06 months amounting to Rs.985,320.00 alongwith plan placed at S.No.2 (A), to attend the same through outsource as the same is beyond the scope of in-house arrangements.
3. Tenders for the work were therefore invited under 36 (a) of PPRA Rules through KPT, MoMA & PPRA Website and received on 16-10-2024.


RECOMMENDATIONS:
