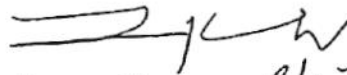

As per above working the proposal furnished by M/s Makkays Pvt Ltd amounting to PKR 5,746,600.00/- inclusive of all applicable tax and overall Total Score of 100 is found most advantageous whereas proposals furnished by

M/s Al-Hamd Engineering Service and M/s Britlite Engineering are found non-responsive and are summarily rejected.
