They have mentioned the 15% SST as Rs 87,150/- (for item # 1 to 7, 9, 11, to 14 & 16). After re-calculated the same and noted that the amount of 15% SST of M/s Al Meena Marine Engineers would be Rs 910,50/- instead of Rs 87,150/- Accordingly, the grand total amount of M/s Al Meena Marine Engineers comes to Rs 1,002,490/- instead grand total amount of M/s Al Meena Marine Engineers of quoted amount of Rs 998,590/-.
