### 5.6 Financial Evaluation

The fee for providing Tax & Financial consultancy services shall be quoted inclusive of all applicable taxes in Pakistan in Form A-4 (Pak. Rupees).

The formula for determining the Financial Score is the following:  $Sf = 100 \times Fm / F$

Where, Sf is the Financial Score; Fm is the Lowest Price and F is the Price of the Proposal under consideration.

The Financial Proposal is the total competitive cost against the desired services quoted by the Consultant in the table under Form A-4.

### **Combined Score**

The Consultant getting maximum marks on 80-20 weightage (80% for technical and 20% for financial) will be selected as Tax & Financial Consultants for the Client. The weights given to the Technical (T) and Financial Proposals (F) are: T = 0.80 and F = 0.20
