INTRODUCTION:

1. Manager (Sports) vide his letter placed at S.No. 1 has intimated that, the Minister of Maritime Affairs & Chairman KPT are expected to visit the subject sports center hence requested to attend the subject work in-order to maintain the sport center in shipshape condition. Accordingly, AXEN (KV) after carrying out detailed survey along with general staff has prepared an Estimate amounting to Rs. 995,353.00 alongwith plan placed at S.No. 3(a) & 3(b) respectively, necessary for attending the work through outsources as the same is beyond the capacity of in-house arrangements.
2. Tenders for the work were therefore invited under 36 (a) of PPRA Rules through KPT, MoMA & PPRA Website and received on 27-12-2024.

RECOMMENDATIONS:

The Single Evaluated / Most Advantageous Bid amounting to Rs.996,489.37 (Rupees: Nine Hundred Ninety Six Thousand Four Hundred Eighty Nine & Thirty Seven Paisa Only) received in accordance under Clause PPRA Rule-36 (a) from M/s. Shahid Trading which is 0.11% above the corresponding estimated cost of Rs.971,071.00 based on KPT revised schedule of rates 2023-24 is considered reasonable. Keeping in view of their past performance as mentioned in para-2 (m), M/s. Shahid Trading is considered capable for carrying out the work viz. **"UPLIFTING OF KPT SPORTS CENTER AT KEAMARI"**.

The Committee therefore, recommends the acceptance of the Single Evaluated / Most Advantageous Bid amounting to Rs.996,489.37 (Rupees: Nine Hundred Ninety Six Thousand Four Hundred Eighty Nine & Thirty Seven Paisa Only) received from M/s. Shahid Trading is considered reasonable for the work viz. **"UPLIFTING OF KPT SPORTS CENTER AT KEAMARI"**.
