MINUTES OF THE MEETING OF THE DEPARTMENTAL TENDER COMMITTEE HELD ON 09-01-2025 IN THE OFFICE OF CHIEF ENGINEER, ENGINEERING DEPARTMENT, K.P.T.

NAME OF WORK: MAINTENANCE AND REPAIRS TO KPT FLAT NO. FK-45 OF KV-04 BUILDING CHEENA CREEK KEAMARI.

INTRODUCTION:

- 1. The Resident of KPT Flat No. FK-45 of KV-04 vide application placed at S.No.1 has requested for the repair & maintenance works of official KPT accommodation, which is in dilapidated condition. The accommodation was visited by AXEN / Sub Engineer (KV) and observed that the KPT official accommodation is in much dilapidated condition and needs repair to make the same in livable condition. Accordingly, AXEN (KV) has prepared an estimate alongwith plan placed at S.No.2 (A) & 2(B), to attend the same through outsource as the same is beyond the scope of in-house arrangements. It is pertinent to mention here that, no work has been done since, from last 05 years at the subject building.
- 2. Tenders for the work were therefore invited under 36 (a) of PPRA Rules through KPT, MoMA & PPRA Website and received on 23-12-2024.

RECOMMENDATIONS:

The Single Evaluated Bid amounting to Rs.997,696.87 (Rupees: Nine Hundred Ninety Seven Thousand Six Hundred Ninety Six & Eighty Seven Paisa Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. Shahid Trading which is 0.55% above the corresponding estimated cost of Rs.992,142.00 based on KPT schedule of rates 2023-24 is considered reasonable. Keeping in view of their past performance as mentioned in para-2 (m), M/s. Shahid Trading is considered capable for carrying out the work viz. "MAINTENANCE AND REPAIRS TO KPT FLAT NO. FK-45 OF KV-04 BUILDING CHEENA CREEK KEAMARI".

The Committee therefore, recommends the acceptance of the Single Evaluated Bid amounting to Rs.997,696.87 (Rupees: Nine Hundred Ninety Seven Thousand Six Hundred Ninety Six & Eighty Seven Paisa Only) received from M/s.
