INTRODUCTION:

1. Female Canteen has been located at the backside of KPT Head Office adjacent to CBA Office. Due to extreme weather in summer it becomes difficult for visitors and employees to stand in extreme heat, therefore concerned AXEN (MIY) has visited the area and proposed the installation of shed for the same.
Accordingly, AXEN (MIY) has prepared an Estimate amounting to Rs.986,527.50 (including Taxes and Contingencies) placed at S.No.1, for attending the work, as the work is beyond the capacity of KPT In-house arrangements.
2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 17-12-2024

RECOMMENDATIONS

The Most Advantage Bid amounting to Rs.998,602.50 (Rupees: Nine Hundred Ninety Eight Thousand Six Hudred Two & Fifty Paisa Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. Global Construction & Engineering which is 01.22% above the corresponding estimated cost of Rs.986,527.50 based on market rates is considered reasonable. Keeping in view of their past performance as mentioned in Para-2 (m) M/s. Global Construction & Engineering is considered capable for carrying out the work viz. **"FIXING OF CANOPY SHED ADJACENT TO FEMALE CANTEEN AT KPT HEAD OFFICE"**.

The Committee therefore, recommends the acceptance of the Single Evaluated Bid amounting to Rs.998,602.50 (Rupees: Nine Hundred Ninety Eight Thousand Six Hudred Two & Fifty Paisa Only) received from M/s.
