INTRODUCTION:

1. As per the request of Dy. Commandant (PSF) placed at S.No. 1, the condition of the subjected area is very pathetic, several attempts have been made to clean the sludge but the problem persists, to replacing the existing sewer with of 6" dia of UPVC sewer is the only solution the hour to cater for the flow of existing sewerage system, in a manner to observe the hygienic condition of the area.

Therefore, AXEN (MIY) has prepared an Estimate amounting to Rs.999,810.00 (including Taxes and Contingencies) placed at S.No.1, to attend the work through outsource as the same is beyond the scope of in-house arrangements.

2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 15-01-2025.

RECOMMENDATIONS

The Single Evaluated Bid amounting to Rs.839,091.75 (Rupees: Eight Hundred Thirty Nine Thousand Ninety One & Seventy Five Paise Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. Mehtab Traders which is 16.07% below the corresponding estimated cost of Rs.999,810.00 based on market rates is considered reasonable. Keeping in view of their past performance as mentioned in Para-2 (m) M/s. Mehtab Traders is considered capable for carrying out the work viz. **"LAYING OF SEWERAGE DRAIN AND REMOVAL OF DEBRIS FROM THE BACKSIDE OF PSF OFFICE AT KPT HEAD OFFICE"**.
