As per Sr. 5 of bid evaluation criteria, the bidder must have inbound call center experience with three references. The references provided by the bidder were not specific to call center services and details of projects provided by the bidder reveals that the bidder provides call services for their core business of courier/delivery. 2) Bidder was requested for provision of audited financial statements for last three years vide: email dated18-02-2022 which was not provided. 3) Committee members visited their Call Center vicinity on 23-02-2022 and committee observed that their Call Center setup was operating in two shifts with a total of 52 No. call center agents which does not meet the requirement of 100 call center agents as per bid evaluation criteria (Sr. no 2).
